## Traffic warnings for Lower Broadway

The Encore Boston Harbor off-site roadway construction is entering the last stretch on Lower Broadway this fall and the next few weeks will be extremely busy, company officials said.

Drivers should take note that there will be many construction impacts in the next few weeks as crews try to wrap up the construction season.

Many crews will be working this weekend on traffic signals, street lights, brick pavers and road paving.

Next week, they will continue to work in the area doing final installation and testing of signals, various utility cross-overs and raised castings.

## Everett honors veterans at the Connolly Center

Numerous Everett officials came together on Monday, Nov. 12, to honor those who served the country in the military for Veterans Day – a ceremony that marked the 100th anniversary of the end of World War I.

The ceremony was kicked off by Veterans Commission-

er Jeanne Cristiano, who noted the 100th Anniversary of WWI and commended all veterans in the room.

The keynote speaker was Army Brigadier General (retired) James Voss, who mentioned that Veterans Day took a different meaning to him after he was in the military.

“For me, Veterans Day is totally different to me than it

was before I joined,” he said. “If has forever changed for me. Memorial Day is another one. It’s a holiday that has drastically changed its meaning for me, as it has for all vets.”

He spoke about the Gold Star mothers, and how we should take care of them. As

## Legal Maneuver

### Steve Wynn sues MGC, Wynn Resorts over public investigation rollout

Former Wynn Resorts CEO Steve Wynn has filed a six-count action in Clark County, Nevada, court calling on the Massachusetts Gaming Commission (MGC) to be barred from publicly rolling out its eight-month investigation into sexual misconduct allegations at Wynn Resorts – a highly anticipated investigation that was supposed to be made public in early December.

Wynn filed suit against the MGC and Wynn Resorts on six counts for allegedly violating his attorney-client personal privilege in handing over documents that were part of court cases when he was part of the company.

Steve Wynn resigned from the company in February and he was deemed a non-qualifier in the Wynn Resorts Massachusetts gaming license in May.

“Because the stated position of Mass Gaming and the continued silence of Wynn Resorts are tantamount to re-

quiring Mr. Wynn to fight this privilege battle while blindfolded and with both arms tied behind his back, he now seeks relief from this Court to redress the breach of his common interest agreements with Wynn Resorts and to enjoin the public dissemination of Mass Gaming’s report to the extent it contains, discloses or otherwise relies upon Mr. Wynn’s protected communications and materials,” read the 20-page filing.

The MGC issued a statement late last week regarding the newly-filed case, saying it was Steve Wynn’s latest legal maneuver.

“The MGC is aware of Steve Wynn’s latest legal maneuver,” said Spokesperson Elaine Driscoll. “This development is not surprising as it is consistent with his established litigious tendencies. The Commission has retained legal representation in Nevada to mount a vigorous defense against his effort

## Sign of things to come Encore street sign and entrance take shape

For nearly two years, the Encore Boston Harbor site has looked like a site.

Construction vehicles, rocks, mud and raw steel coming out of the ground. It was a place where work was getting done, albeit and the speed of light.

Now, however, the Encore Boston Harbor sign has gone up on Lower Broadway, and the entrance is beginning to take shape just north of Horizon Way. On the roadway, median strips have been laid out and paving is about to start in several days.

The site is quickly becoming the destination.

After a few weeks of work, the Encore Boston Har-

bor sign emerged on Lower Broadway as a reality check on what is to come in eight short months.

Spokesman Greg John said the sign is not flashy or full of neon, but dignified and “five-

star.”

“Our experience starts when you drive up and see our sign and the landscaping out front,” he said. “We want it to be beautiful and spectacular. As good as it might look now, it will be much, much better by the time we open. I don’t think Encore would put up a sign that isn’t five-star. Everything we do represents luxury and elegance and doesn’t scream out Vegas. We’re not big on neon.”

The sign is 72 feet high and made by the same company, Yesco, that made the Encore

signature letters on top of the tower building. The sign is an oval, cream and bronze colored, with the ‘Encore’ signature on both sides.

John said the design for the sign was similar to one that was in Las Vegas, but the Wynn Design and Development team put some unique features in the Everett sign.

“It was really designed to fit into the environment here,” said John. “When you’re on I-93 you see the building and there is a sense of amaze-

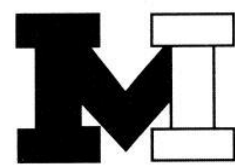

Noted Everett firefighter, veteran passes suddenly

Everett Firefighter Thaddeus ‘Tad’ Baxter passed away suddenly late last week, leaving yet another sad situation at the Everett Fire Department.

For the Department, it comes after they lost one firefighter to occupational cancer this summer, and saw two firefighters injured – one severely - during a major fire last summer as well.

Baxter, 43, leaves his wife, Nicole, who was very active with the Fire Department wives group, and two daughters, Casey, 19, of Merrimack College, and Madison, 17, of Woburn High School.

Baxter had been on the job for 13 years, having taken a stint in the middle to become a police officer for a while, returning shortly afterward though. He worked on Engine 2 and Group 4, but truly distinguished himself as the commander of the EFD’s vaunted Honor Guard.

“His girls were his world,” said Craig Hardy, president of Firefighters Local 143. “This is a tough one. He was only 43...We’ve had a really tough year to say the least. This one really ripped our hearts open wide. Tad did so many things for friends, family and members that no one knew about. He did Local 143 proud with the Honor Guard and made it so important throughout the state because of his presence and how he served us. He’s known for that throughout the state for sure.”

Fire Chief Tony Carli said Baxter was always there to be



counted upon and his loss has weighed heavy on the Department.

“He was one of the guys always around the Fire House whether on duty or off-duty, he would always stop in,” he said. “It’s been very tough. We’ve been talking with all of the firefighters and making sure everyone’s okay. I’m not going to lie, though, it’s been a tough year with losing one firefighter to cancer and having two others injured. For a department of 100, that’s a lot and we’re dealing with some serious things. However, there is a lot of truth to the fact that the fire service is a big family, not only the members, but also for Tad’s family.”

Carli said he was best known for his work on the Honor Guard.

“He’s well regarded statewide for that,” he said. “We’ve been recognized as one of the top Honor Guards around. He organized it and helped people to take it seriously.”

Mayor Carlo DeMaria held a moment of silence for Baxter on Monday before the Veterans Day ceremony, as Baxter had been an Army veteran

too.

“I’m heartbroken to hear about the passing of Everett firefighter, Thaddeus Baxter,” said the mayor. “Thaddeus was not only a firefighter, but also a husband, father, and a great friend to all of us. His family and fellow firefighters are in my thoughts and prayers. This loss leaves a great void in our city and he will be greatly missed.”

Hardy said Baxter did suffer from Post-Traumatic Stress Disorder (PTSD) and it weighed heavily on him and his career.

That, Hardy said, was a lesson for all firefighters and veterans to seek help as Baxter did.

“That weighed in on him heavily,” he said. “We should all be making sure those around us in the fire service are okay, and reaching out when we can.”

Said Carli, “We’re very conscious of the mental stress this job brings to our members. We work hard to provide them with the tools to get the job done and to take care of themselves as well.”

The wake for Firefighter Baxter will take place today, Nov. 14, from 4-8 p.m. at Cafasso and Sons Funeral Home, 65 Clark St., Everett.

ment. We want to continue that sense of amazement when you drive up Rt. 99. It’s meant to create a sense of luxury before you step one foot in the building.”

That’s the case for the entire district, as he said the new median strips will be thoroughly landscaped next spring to reflect the landscaping that is now taking shape at the entrance.

John also gave credit to the City for helping to design the entrance and the sign to match the Lower Broadway plan.

“You have to credit the City of Everett too,” he said. “We worked closely with the City to make sure the design for the sign and the entrance was in line with the Lower Broadway Plan. There is a Lower Broadway plan which we have supported from day one and will continue to support. We don’t want to put something in there that doesn’t align with the area. We want to something that’s beautiful now and years from now.”

to block the release of our months-long investigatory report and to defend against Mr. Wynn’s baseless claims for damages against the Commission and its Director of the Investigations and Enforcement Bureau. It is our intention to bring this matter to a swift resolution. The IEB remains focused on its preparations to soon present the Commission with the full extent of its findings.”

Driscoll’s statement seemed to indicate the MGC believed they would still be able to hit the December timeframe for beginning to release the report, which has been delayed several times over the past few months.

Steve Wynn’s claim indicates the problem goes back to the Okada/Azure litigation that began in 2012, and was settled in the spring of this year. He said there was an agreement in place, though not in writing, that his attorneys and the company attorneys would work in tandem in the litigation – which involved a dispute over the sale of stock.

Because of that alleged agreement, Wynn says many of the documents from that case turned over to the MGC by Wynn Resorts as part of the state investigation were privileged.

However, he wrote, he and his attorneys in Boston and Nevada were not able to review any of the submissions from Wynn Resorts, a matter

that was brought up in a letter to Wynn Resorts in July.

The matter, Wynn wrote, was also brought up to the MGC as well, saying attorney-client privilege had likely been violated.

Finally, not long ago, Wynn’s attorney in Boston, Brian Kelly of Nixon Peabody, was able to review a small batch of submissions that the MGC provided.

Wynn alleges those reviews confirmed what he believes are attorney-client privilege breaches.

“Those documents confirm the Company has, in fact, improperly disclosed Mr. Wynn’s protected communications at the unrelenting behest of Mass Gaming officials,” read the filing. “Mass Gaming has announced its intention to issue a public report concerning the results of its investigation by early-December 2018. Recognizing that they have conducted their months-long investigation into Wynn Resorts with total disregard for protecting the privileged communications of Mr. Wynn—who, again, has no ability to determine what communications and materials have been provided to regulators—Mass Gaming officials have simply donned the judge’s robe, cracked the gavel, and unilaterally determined that Mr. Wynn has failed to sustain his burden of establishing that any privilege applies to the unknown universe of documents acquired

during the Mass Gaming investigation.”

Wynn even alleges that MGC Investigator Karen Wells violated several privileges while questioning witnesses in Nevada during the inquiry. He said he learned this from individuals that were questioned, and informed the MGC of this allegation on Oct. 23.

“Mr. Wynn also notified Mass Gaming that he had learned...that Ms. Wells, a licensed attorney, had repeatedly posed questions during the interviews that sought to invade Mr. Wynn’s personal privileges,” read the filing. “Ms. Wells was of the apparent belief that she could invade Mr. Wynn’s privileges because Wynn Resorts had purportedly waived all of its privileges. The attorney representing the interviewees specifically noted the impropriety of such questioning without a waiver by Mr. Wynn (which had never been provided), objected thereto, and instructed the witnesses not to answer despite Defendant Wells’ objections to the instructions.”

The suit, in total, asks Wynn Resorts to stop turning over documents to the MGC that could be protected without first consulting Steve Wynn or his representatives. It also calls for the court to prevent the public rollout of the MGC investigation in December until the privilege questions are settled.

round, and are targeting Everett women in particular.

“It’s odd because we didn’t get a large percentage of students from Everett,” said Williams. “I’m not sure if they were afraid or just didn’t take action. In any case, the call is out for Everett residents to apply for the next round and there

are scholarships still available for Everett residents. We really want Everett people to apply and use those scholarships. We also have scholarships for veterans too.”

To that end, Encore is having a promotional event for Everett women on Nov. 26 in the Connolly Center to try to

get more women interested in applying for Dealer School.

“We will have two women there who work for us, and they will be talking about how they got onto their career path for dealer games,” he said.

Michelle McMahon will talk about how she began in 2008 as a dealer and then worked her way up to becoming a trainer in 2014, moving on now to train for Encore Boston Harbor.

Sue Mason will discuss how she decided to try being a dealer in 1998, taking a class and getting hired on a whim at Foxwoods. By 2013, she had become a Pit Manager and will be one at Encore Boston Harbor when it opens next year.

“The career path right now is wide open,” said Williams. “If you go to a casino when it first opens up, there is a lot of movement. If you’re focused and determined, there are opportunities for everyone right now. It’s an even playing field.”

The Dealer School formed last spring and launched this fall with the first class of students. Williams said they are wrapping up classes right now and expect to be done by Thanksgiving. However, he said that 75 percent of the students have stayed on to learn a second game and they’ll be done before Christmas.

The second round will begin soon afterward, and Williams expects 200 or more students in that round.

FBI warns posting hoax threats is a crime; launches campaign to educate the public

The FBI Boston Division is launching a public awareness campaign to educate the public about the consequences of making hoax threats of violence to schools, events, and other public places, and reminds everyone that any threat is taken with the utmost seriousness and will be quickly and thoroughly addressed by law enforcement. Hoax threats are not a joke, they are a crime!

In the aftermath of tragic shootings such as the ones at Santa Fe High School in Texas and Marjory Stoneman Douglas High School in Florida, the FBI and law enforcement agencies around the country often see an increase in threats made to schools, events, and other public buildings.

“You might be angry, you

may be joking, or looking for a way to be heard, or seek revenge, but you need to stop and think before you post because making any threat, even a hoax, has consequences. It drains critical law enforcement resources, diverts first responders away from actual emergencies, and is an unnecessary burden on the taxpayers,” said Harold H. Shaw, special agent in charge of the FBI Boston Division which covers all of Maine, Massachusetts, New Hampshire, and Rhode Island. In the last five years, the number of hoax threats made against schools and other public places through various social media platforms here in the Boston Division have tripled. “Based on our estimates, we’re receiving reports of at least two threats a day that turn out to be hoaxes,”

added Shaw.

When an investigation concludes a false or hoax threat has been made to a school, events or another public place, state or federal charges could be levied. A federal charge carries a maximum sentence of five years in prison.

Public assistance is crucial to our efforts to curb these hoax threats. We ask that the public continue to contact law enforcement to report any potential threats or suspicious activity. If there is any reason to believe the safety of others is at risk, we ask that the public immediately reach out to their local police department by calling 911.

Early intervention can prevent a situation from escalating by identifying, assessing, and managing the threat. Remem-

ber, if you see something, say something. Hoax threats are not a joke, so think before you post!

A limited amount of posters are available for distribution to area schools upon request. What Should You Do to Help?

- Don’t ever post or send any hoax threats...period.
- If you are a target of an on-line threat, alert your local law enforcement immediately.
- If you see a threat of violence posted on social media, immediately contact local law enforcement or your local FBI office.
- Notify authorities, but don’t share, forward or delete the threat until law enforcement has had a chance to investigate—this can spread misinformation and cause panic.

holiday weekend could become the backup plan.

The traffic impact will be to close one side of the highway on Rt. 99 from end to end at a time. Also, between the milling and paving operations, there will be about two

well, he spoke about veterans who come back and lives quiet lives – but suffer from the silent wounds of war. To that, he held up his ring finger that bore a symbol for veterans who have committed suicide – a trend that comes at about 22 per day.

In conclusion, he said that it is about defending freedom, and that is something none of us can be lax upon.

“The defense of freedom is not just for those in the military,” he said. “We can protect our freedom by continuing to speak out against injustices. Make sure your values in your community reflect the freedoms promised to us as Americans. We can never let our guard down.”

Mayor Carlo DeMaria noted that the current war on terror has lasted 17 years with no end in sight. He recognized Sean Yebba, who fought in the war and received two Purple Hearts.

“We recognize there are those who walk among us and who did walk among us and have passed on that gave a piece of their lives to make sure we remain free,” he said. “We’ve been at war since 2001. The U.S. has fought for 17 years every day with no end in sight. We need to keep those men and women who have fought in our minds.”

State Sen. Sal DiDomenico said he grandfather fought in World War II, but rarely talked about it – even refusing to go back to Italy to visit the war memorials later in life.

“He was in battle and storming the shoreline with two friends running by his side,” said DiDomenico. “As they ran to the shore, his two friends were killed and he kept running forward. He held that in his whole life. We didn’t know that story until his wake. Our state is the best when it comes to veterans benefits and we do good

in many cases. But we fail in many cases because even if there is one veteran who is homeless, who needs food or who needs a job, then we have failed as a society. They completed their mission. Our mission is to take care of them and give them what they deserve.”

Supt. Fred Foresteire recalled the inauguration of John F. Kennedy 57 years ago, and the words he spoke having been a decorated veteran of WWII.

“On this Veterans Day, I want you to know I am most grateful to the young men and women of Everett that when summonsed for the call of liberty, they answered that call,” he said.

The ceremony ended with the Everett High School band playing an Armed Forces Medley, and then concluded with Taps.

Encore employee parking plan in the Village gets first airing at ConCom

The public will get its first real view of the Encore Boston Harbor plan to locate a 625-car employee parking lot on Air Force Road in the Village during a Conservation Commission meeting Thursday, Nov. 15.

Encore, operating the proposal under 68 Tremont Street, LLC, filed its Notice of Intent with the Everett Conservation Commission on Nov. 1, and will have the matter heard on Nov. 15 at the regular meeting.

While the ConCom is narrowly focused on issues such as drainage and stormwater, the matter is the first public airing of the proposal. As outlined in the ConCom filing, the proposal is to put a 625-car RiverGreen Parking Facility on Air Force Road next to the new Boston Freightliner building. The large parking lot would serve as an employee lot and would include a shuttle service and shelter. It would operate 24-hours per day and would also have a security element on site as well.

The plan did say it would be on a temporary basis for three years.

“The use of the site for parking as a principal use will be on a temporary basis during the planning and construction of the RiverGreen development (approximately

three years),” read the filing.

There are no buildings proposed, but there would be a shelter constructed for those waiting on the shuttle. Already, one shelter has been constructed on the site, and a third would also be proposed by the new playground on RiverGreen Drive.

The filing indicates that the project would continue the redevelopment of a Brownfield (polluted) site that has failed to be developed on two separate occasions already. The filing said that Encore has already made significant steps in developing Freightliner and open space.

“The current project represents yet another significant step toward redevelopment of the former GE property,” read the filing. “When completed the parking facility will significantly improve the aesthetic qualities of the site and surrounding uses by incorporating landscape buffer areas and extensive landscape plantings.”

Other benefits cited would be activating the area, stabilizing open soil areas and mitigate the soils for future development.

“The project as proposed will serve to prepare the site for permanent future development by performing excavation and construction below the clean soil cap where required,” read the filing. “The fill will also serve to further

isolate and cap the underlying contaminated soils, at which point the majority of the risks associated with working on the site will be mitigated for future use.”

The project will also include and extensive drainage and stormwater system for the lot.

Encore officials said last month the area had been targeted for relocating industrial businesses from Lower Broadway. However, only Freightliner took advantage of that program, leaving about 7 acres left for development. While Encore could sell the land to an industrial developer – of which there are many – the company and Mayor Carlo DeMaria put together a plan to keep the parking in Everett and preserve the site for a better use - such as a hotel or residential development.

City officials have been mum on the proposal so far, and environmental groups have not made any public statements as of yet.

Meanwhile, many neighbors and Councilor Michael McLaughlin have voiced concerns about how so many cars would move in and out of Air Force Road and Santilli Circle around the clock without destroying their quality of life.

McLaughlin said this week that he is reserving judgment on the plan for after the presentations.

Encore Boston Harbor to sponsor Henri de Toulouse-Lautrec exhibit

Wynn, co-founder of Wynn Resorts, which owns Encore Boston Harbor. “As

a long-standing patron of the arts, I am impressed with the breadth of the MFA’s programming and pleased to see Encore Boston Harbor partner with this important civic institution.”

Toulouse-Lautrec and the Stars of Paris will open at the MFA in April 2019, and will include more than 200 of Toulouse-Lautrec’s posters, prints and paintings that are currently being housed at the MFA and the BPL. More than 100 pieces in the exhibit will come from the BPL’s collection, making this one of the largest loans of artwork ever made by the library to a single institution.

Showcasing Toulouse-Lautrec’s acclaimed bold colors and radical compositions, the exhibit will explore the artist’s attention to the stars and entertainments of 19th-century Montmartre, the bohemian center of Parisian nightlife.

The exhibit will examine how Toulouse-Lautrec pushed his art in new directions to portray the celebrity culture of his time – equally fascinated, much like today, with the performers’ personal lives as with the roles they played. Using brazen colors and expressive lines, the artist depicted the defining gestures, costumes and expressions of the celebrities of the day, many of whom were his personal friends. His images of performers—including cabaret stars Yvette

Guilbert and Aristide Bruant, dancers Jane Avril and Loïe Fuller, and actress Marcelle Lender – contributed to their fame. Additionally, the exhibition will incorporate works by Toulouse-Lautrec’s contemporaries Edgar Degas, Honoré Daumier, Pierre Bonnard, Edouard Vuillard and others.

Throughout the month of June 2019, BPL cardholders can sample MFA membership by presenting their library card at any ticket desk to receive free admission to the museum (for two adults and up to six children per visit). ## Gov. Baker, 'No on 1' big winners in Everett

Everett followed the trend of the state in going all out for Republican Gov. Charlie Baker in Tuesday's General Election -- voting for Baker with 57 percent of the vote.

Challenger Jay Gonzalez, the Democrat in the race, received 42 percent of the vote, or 4,231 votes. Baker received 5,758 votes in Everett.

Gov. Baker has been popular in Everett and has made several visits over the past few years.

Statewide, Gov. Baker got 67 percent of the vote to Gonzalez's 33 percent.

During his victory party at the Hynes Convention Center in the Back Bay, Baker said his administration will continue to build bi-partisan relationships to tackle the tough issues.

"The people of Massachusetts elected us four years ago to bring fiscal discipline, a reform-minded approach to governing, and a commitment to bipartisanship to state government," he said. "We have done just that. Every single day. And today, the voters have spoken. They like what we are doing and they appreciate the way we work. So here's the good news. That collaborative, purposeful and humble approach to governing is exactly what you are going to get from us and from our team for the next four years. Non-stop. Let's rock."

The biggest draw at the polls last Tuesday, however, was the race between U.S. Sen. Elizabeth Warren and Challenger Geoff Diehl, where 10,092 votes were cast -- the largest number cast in any race on the night in Everett.

The race was interesting here due to the fact that the two public safety police unions in Everett had publicly backed Diehl, mostly due to comments made last summer by Warren disparaging those in the criminal justice system.

That support in Everett, though, didn't seem to make the race any closer, with Warren winning 69 percent of the vote to Diehl's 27 percent.

Though unopposed, both of the state elected officials on the ballot in Everett checked off quite a vote.

State Sen. Sal DiDomenico gathered 8,530 votes in Everett.

DiDomenico had a strong show of support throughout his district with an impressive vote of confidence in every corner of the Middlesex and Suffolk District. The breakdown of his totals are as follows: Cambridge (18,876 votes - 99.16%); Boston neighborhoods of Charlestown, Allston, Brighton and the West End (12,549 votes - 98.50%); and Chelsea (5,409 votes - 98.20%).

"I want to thank the residents of the Middlesex and Suffolk District for their continued trust and confidence," said DiDomenico. "It is an honor and privilege to be your State Senator and look forward to continuing the work we have started together."

Sen. DiDomenico will be sworn back into the Senate this coming January and he serves as the body's Assistant Majority Leader.

Meanwhile, State Rep. Joe McGonagle Jr. received 8,292 votes (98 percent) on Election Day as well.

McGonagle thanked the residents of Everett for returning him to office for another

term, and said he plans to focus on priorities set out in the campaign, such as affordable housing.

On the questions, perhaps the most visible item on the ballot was Question 1 concerning mandated nurse staffing ratios. In what had been an expensive and confusing campaign for voters, the Question was defeated easily in Everett and statewide.

More than 9,000 votes were cast in Everett on Question 1, and the 'no' vote prevailed with 68 percent of the vote (6,372 votes).

Similar to the statewide results, Question 2 (campaign finance) and Question 3 (transgender legislation) also easily prevailed in Everett with 68 percent of the vote and 62 percent of the vote.

Congresswoman-elect Ayanna Pressley, who was unopposed, received 98 percent of the vote.

Meanwhile, Everett's Terrence Kennedy just edged out challenger Vincent Dixon for the Governor's Council seat.

All other state and county officeholders won easily or were unopposed.

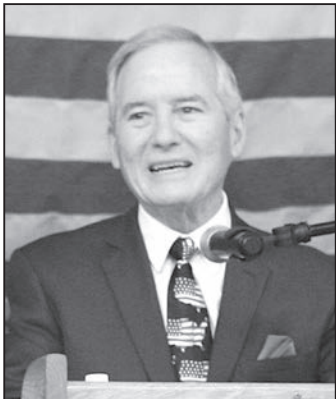

DiDomenico announces new civics education law

Sen. Sal DiDomenico recently announced a new civics education law aimed at strengthening civics education in the Commonwealth's public schools by taking a nonpartisan approach to civic engagement projects and awareness programs starting in the eighth grade.

Sen. DiDomenico and his colleagues in the Massachusetts Legislature passed this piece of legislation in July and Governor Baker signed a revised version of the bill last week. DiDomenico was a strong supporter of the bill and greater civics education in the Commonwealth.

"Now more than ever, civics education is of the highest importance to teach and prepare our next generation

of leaders," said Sen.DiDomenico, Assistant Majority Leader of the Massachusetts Senate. "I am confident that this law will empower youth with the tools and knowledge they need to be well-versed in our electoral system and legislative process, and will ensure that they are ready to be active participants in our democracy."

The law requires every school district that serves students in eighth grade or high school to offer all students the chance to participate in a non-partisan civics project. State officials will also be required to develop a voter registration challenge, to encourage students get their classmates to register or pre-register to vote.

The law also implements new requirements for civics education. Schools will now be required to teach:

- the state and U.S. constitutions;
- the Bill of Rights;
- local history and government;
- the branches of government;
- the responsibilities of a citizen in a democracy;
- digital media literacy;
- issues related to diversity and power; and
- etiquette regarding the flag.

A trust fund will be created to help school districts develop curricula that adhere to the new state history and civics education requirements.

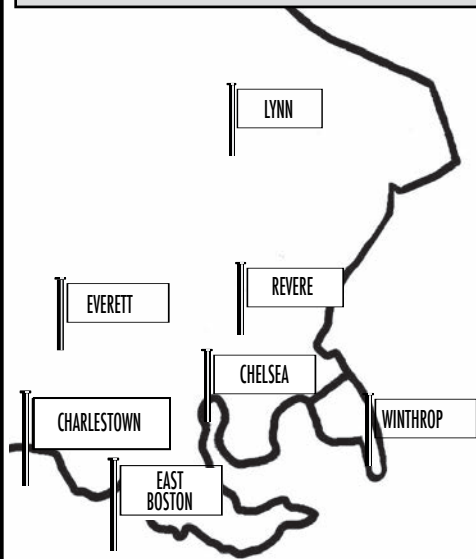

The **Everett Public Schools** scheduled a variety of events for the first-ever Massachusetts STEM Week, an effort to boost students’ interest and awareness of science, technology, engineering, and math education. Chief among them were two Everett High School (EHS) open houses for eighth graders, who visited classrooms, talked to teachers and students, and learned about the ways in which STEM education is interwoven across a wide range of programs, pathways, and clubs and organizations.

Accompanied by EHS Ambassadors, the eighth graders toured the new spaces created for the Career and Technical Education (CTE) program and engaged in hands-on projects. They also had the chance to convene in the gymnasium to work with the remote-control race cars that STEM Club students design, assemble, and operate for competitions.

From Digital Photography to Engineering and Robotics, the eighth graders were exposed to the exciting opportunities that characterize EHS’s STEM programs. Of particular interest were Mr. Kevin Szulak’s Marine Biology class where beach erosion projects were on display, and Ms. Susan Lomas’ Health Assisting class where high school students role-played a medical emergency. An engaging origami activity in Mr. Thomas Meehan’s class provided students a better understanding of the practical and fun applications of geometry.

The open houses were particularly helpful in showing the eighth graders that STEM represents so much more than taking individual courses in science and math. STEM education has a place in the four academies of EHS: Science, Technology, and Engineering; Business, Hospitality, and Culinary Arts; Health, Law, and Public Service; and Construction, Machining, Architecture, and Environmental Design.

The Baker-Polito Administration held the inaugural, statewide “STEM Week” from October 22-26, asking educators at all grade levels to participate by planning lessons, events, and activities focused on science, technology, engineering and math throughout the week.

Students were encouraged to take part in hands-on learning that aligns topics across STEM subjects and connects to other curricula, with an emphasis on middle and high school students, who are on the verge of thinking about college and careers.

“While we know that STEM education happens all year long at schools across the Commonwealth, we look forward to the hands-on projects and lessons that will be on display during STEM week next fall,” said Governor Baker. “Creating opportunities for more students to pursue STEM fields after high school will continue to improve our education system, workforce and economy.”

The Everett Public Schools (EPS) was an enthusiastic participant in the Commonwealth’s first-ever STEM Week. Thanks to the leadership of Science Director Ann Ritchie and teachers throughout the district, events were scheduled throughout the week. In addition to the two open houses at EHS, there was a special “Fall into STEM” event for English Language Learners facilitated by the group Science From Scientists; a fortunate group of EHS students had the chance to tour the Novartis Community Exploration and Learning Laboratory in Cambridge; and engineers from the Environmental Protection Agency visited the Parlin School, where students played a board game developed by the EPA to teach students how cities and town make energy decisions.
