Arbor Day Foundation Names the City of Everett a 2022 Tree City USA

Everett, MA – The City of Everett, in partnership with the Massachusetts Department of Conservation and Recreation (DCR), hosted an event in

celebration of Arbor Day outside of the Old Everett High School. The event also promoted the DCR's Greening the Gateway Cities Program (GGCP) and coincides with the City of Everett being named a 2022 Tree City USA.

The event brought to-

gether Mayor Carlo DeMaria and City staff, Senator Sal DiDomenico, State Rep. Joe McGonagle, members of DCR, Everett Community Growers and Webster Extension Pre-K students and teachers to plant a Dutch Elm tree that is resistant to Dutch elm disease.

The City plans to plant 600 trees this year, which includes 200 trees that were planted at the recent Earth Day event and ongoing DPW street plantings.

Starting this spring of 2023, GGCP will offer Everett residents free tree

DiPierro to seek Ward 3
City Council seat

Anthony DiPierro has officially announced his intention to return as Everett's Ward 3 City Councilor. DiPierro was first elected in 2015 and served as the Council's President in 2017, followed by appointments to serve as Chair of Council's Government Operations Committee, Legislative Affairs and Elections Committee and then finally the Budget Committee before leaving the City Council in 2022.

The following is Anthony DiPierro's statement:

"Everett's best days are undoubtedly ahead. The decisions we make today will continue to shape our City for generations to come. As we continue to grow, we must maintain the integrity of our neighborhoods while protecting and improving our quality of life, DiPierro said in an open letter to Ward 3 Residents this past week. "We must work together as one to seize every opportunity for positive action. Now, more than ever - I am ready to be that leader," he added.

Anthony DiPierro is a life-long Everett resident and a graduate of Everett High School. He went on to earn a Bachelor's Degree from Suffolk University in American Government and Politics. DiPierro got involved in local government at a young age, realizing that public service is an effective and concrete way to give back to your commu-

nity. After volunteering on numerous local and state-wide campaigns, he decided to pursue a career in public service. He first ran for City Councilor with the belief that taking the knowledge you learn on doorsteps across the city back to City Hall is how you make government work for all. He knows that working together respectfully is how we get the best results for people who live and work in our city.

Since leaving office, DiPierro has become a homeowner in Ward 3 and continues to work as a Property and Casualty Insurance Agent on Broadway in Everett. His civic engagements include fundraising for childhood cancer awareness and participation in a wide range of Everett activities. He recently furthered his education by earning a Diversity, Equity and Inclusion certificate from Suffolk University's Center for Continuing and Professional Education. PROPOSAL:

The owner wishes to erect an accessory structure on the side yard to be a separate dwelling unit bringing the total number of dwelling units on the property to three (3). The separate dwelling unit will have a total square footage of 3,337 S.F. The lot is 10,982 S.F. The current structure on the property was erected in 1948.

Reason for Denial:

Pursuant to Section 4(A)(1), a single or double semi-detached dwelling existing at the time of the first enactment of the Zoning Ordinance may be converted to provide not more than a total of three (3) dwelling units. This provision does not apply to the proposed use, since the existing structure was constructed after the first enactment of the Zoning Ordinance in 1926 and because the new dwelling unit will be in a fully detached structure. Accordingly, a use variance is required.

Pursuant to Section 4(B)(2)(c), maximum floor area ratio is .50. Though no FAR calculation is provided, it appears that this standard will be exceeded with the construction of a new unit. The applicant should provide certification of the new FAR and, if in excess of .50, must obtain a variance.

Pursuant to Section 17.A.1 of the Zoning Ordinance, a three-unit residential use would require six (6) parking spaces, but the lot contains only five (5) parking spaces. You may either reconfigure your site plan to create a sixth parking space, seek a variance from the Zoning Board of Appeals or participate in the Transportation Demand Management program under Section 35 of the Zoning Ordinance.

Reason for Denial:

Permit was denied in accordance with the City of Everett Zoning Ordinance Appendix A as follows:

Violations and Zoning:

- The proposed rear Yard is shown to be 15 feet but per Section 26 (c) Dimensional requirements line 4 requires 25 feet.
- Section 26 C) line 7 allows for 70 units per acre where the lot is only 12,629 square feet in area which would allow for a maximum of 20 units
- The proposed side yards while both meet the minimum the total is not meet per Section 26 (c) Dimensional Requirements 3 requires 30 feet total.
- The proposed building a FAR of 2.5 which requires a Special permit per Section 26 (c) Dimensional requirements limits FAR to 2.25 but 4 to 1 by Special Permit.
- Parking of 13 parking spaces is shown to be below the requirements of Section 17 for Off-Street Parking but the owner can go before the Everett Planning Board under the guidelines in Section 35 the Transportation Demand Management (TDM).
- Landscaping requirements indicated on provide plot plan are not clear as to the depth at the Rear per Section 26 Dimensional requirements (d) requires at least 10 feet at the rear lot lines.

around the exploration of concepts such as unconscious bias, cultural intelligence, humility, privilege, power and more.

plantings for their properties. This program targets concentrated Environmental Justice neighborhoods and areas within gateway cities with lower tree canopy, older housing stock, higher wind speeds and a larger renter population. Addressing our urban tree canopy will address both environmental and public health needs in our city. For more information on how you can plant a tree on your property, visit maurbancanopy.org.

The City of Everett was also named a 2022 Tree City USA by the Arbor Day Foundation. Four requirements must be met to attain Tree City USA status. They are 1) maintaining a tree board or department, 2) having a tree care ordinance, 3) dedicating an annual community forestry budget of at least \$2 per capita and 4) having an Arbor Day observance and proclamation.

“The City of Everett has been and will continue to be committed to maintaining effective urban forest management,” said Mayor DeMaria. “It is a privilege to be named a 2022 Tree City USA, and I would like to thank the Arbor Day Foundation for this distinguished honor.”

“Tree City USA communities see the positive effects of an urban forest firsthand,” said Dan Lambe, chief executive of the Arbor Day Foundation. “The trees being planted and cared for by Everett are ensuring that generations to come will enjoy to a better quality of life. Additionally, participation in this program brings residents together and creates a sense of civic pride, whether it’s through volunteer engagement or public education.”

Arbor Day is a holiday that celebrates the planting, upkeep and preservation of trees. The day is often recognized by bringing the community together to plant a tree and acknowledging the importance of trees to our environment.

Applicant seeks to remove the rear portion of the existing commercial building and a small building at the rear of the property, to renovate and continue to use the remainder of the existing first floor commercial space, and construct a new 4 story addition in the rear for 33 residential units with on grade parking and commercial space under the residential units. No residential units will be located on the first floor. The use designation is mixed use as authorized under Section 6(A)(8) of the Zoning Ordinance.

Reason for Denial:

Permit was denied in accordance with the City of Everett Zoning Ordinance as follows:

Violations and Zoning:

- The Proposed use of the property as a mixed use (residential and commercial) building requires a special exception from the City Council, Pursuant to Section 6(A)(8) of the Zoning Ordinance or a use variance from the Zoning Board of Appeals. If you seek a special exception from the City Council, you must first obtain a variance from the frontage and lot area requirements of Section 6(A)(8)(a)(1), as set forth below.
- Pursuant to Section 6(A)(8)(a)(1), mixed use buildings require lot frontage of at least 200 feet and lot area of at least 30,000 square feet. The lot frontage of the subject property is only 117.85 feet, and the lot area is only 20,774 square feet. A variance from the Zoning Board of Appeals is required.
- The proposed Floor Area Ratio (FAR) is 2.22, whereas the maximum allowed under Section 6(B)(2) is 2.0. A variance from the Zoning Board of Appeals is required.
- Pursuant to Section 2 (1st par.) of the Ordinance, the applicant has elected to designate the Chelsea Street frontage of the property as its front lot line. Because it is a through lot, proposed for mixed use, no front or rear setback is required.
- Because the subject property abuts a lot containing a three-family structure, and the proposed structure exceeds 30 feet in height, a side setback of 7 feet is required, pursuant to Section 6(B)(5) of the Ordinance. The existing structure is nonconforming, and the proposed development will result in a substantial height increase within the nonconforming setback. A special permit is required from the Zoning Board of Appeals to alter the nonconforming structure, pursuant to Section 3(C) of the Ordinance.
- Note also that the project will require compliance with Transportation Demand Management under Section 35 of the Ordinance.

THE EQUATION IS VERY SIMPLE: MORE GUNS = MORE SHOOTINGS

Although mass shootings -- especially in schools -- typically draw the most attention from the media, the reality is that these shootings account for a very small percentage of death-by-firearms in our country.

The recent spate of random, isolated shootings -- the 16 year-old boy who was shot by an 84 year-old man in Kansas City when he mistakenly knocked on his door; the 20 year-old young woman who was shot by a 65 year-old man in upstate NY when her car mistakenly drove up the wrong driveway; the six year-old girl and her father who were shot by a 24 year-old man when her basketball rolled onto his property in No. Carolina; the high school cheerleader who was killed when she mistakenly approached the wrong car in a parking lot in Texas; and the murder of a family of five in Texas by a man who was target shooting with his AR-15 late at night -- are more typical of the manner in which innocent Americans (in shootings that are not crime-related) are killed by firearms.

Gun murders have climbed sharply in recent years. About 80% of murders in the U.S. in 2021 -- 20,958 out of 26,031 -- involved a firearm. That marked the highest percentage since record-keeping began in 1968 and represents a 75% increase in the past 10 years.

However, fatalities in mass shooting incidents in 2021 totaled only 706 Americans, accounting for a small fraction of the 20,958 murders-by-guns.

Similarly, while mass shootings in schools make the headlines, they account for only a very small proportion of gun deaths among children. The number of American children killed by firearms has risen dramatically in the past two years by almost 50%, from 1,732 in 2019 to 2,590 in 2021.

It should surprise no one that the states with the highest rates of gun-related deaths -- counting murders, suicides and all other categories -- include Mississippi (28.6 per 100,000 people), Louisiana (26.3), Wyoming (25.9), Missouri (23.9) and Alabama (23.6), all of which have lax gun ownership laws (as well as "open carry" and "stand your ground" laws).

By contrast, the states with the lowest rates include New York (5.3), Rhode Island (5.1), New Jersey (5.0), Massachusetts (3.7) and Hawaii (3.4), all of which have strong gun laws.

More tellingly, our death rate by firearms of about 10 per 100,000 Americans is far higher than in countries with strict gun ownership laws, such as Canada (2.1 per 100,000) and Australia (1.0), as well as European nations such as France (2.7), Germany (0.9) and Spain (0.6).

The equation is very simple: More guns = more shootings -- a trend that is increasing in our country with no end in sight.

DIANNE FEINSTEIN SHOULD RESIGN

California senator Dianne Feinstein, who is 89, has been too ill to show up to the Senate since February. As a result, the Senate Judiciary Committee, of which Feinstein is a member, has been unable to move forward on scores of judicial nominations by President Joe Biden.

And just this past Thursday, the Senate voted 50-49 to overturn a critical Biden administration effort to control truck emissions.

Feinstein, who has been in the hospital with shingles, has missed 75 percent of the Senate votes this session, and has not indicated when (if ever) she plans to return.

In addition, Feinstein's mental acuity has been in question for many months.

We wish to make two points about elected public officials who clearly are incapable of performing the duties of the office to which they have elected and for which they have taken a solemn oath:

First, elected public officials are not "owed" anything, regardless of how many years they have served in office. When a person runs for office, the obligation is strictly one-way: They are public servants, and if they no longer are capable of serving their constituents, they should place the public interest above their own ego and should leave.

Second, a public office is not like any other job. If any of us call in sick or go on leave, someone else will step in to do our job. But that is not true of a public official, for whom there are no "subs."

Dianne Feinstein has had a long and laudable career of serving our country -- and she should continue to do so by resigning forthwith.

Rep. Garcia, House pass FY24 budget, makes investments to support families

The Everett High baseball team earned a pair of exciting victories this past week in contests with Greater Boston League rivals Medford and Somerville.

Lara came on to pitch a scoreless bottom of the

seventh to earn the W".

"As a coach, especially in the sport of baseball, it's important to preach mental toughness," said EHS head coach Joel Levine. "You can't get too high when things are going well, and you can't get too low when we are struggling."

"I thought our kids showed great resiliency after having a really difficult inning and surrendering such a large lead," Levine continued. with the go-ahead run.

“For the third time in our last four games, we entered our last at-bat trailing and ended up winning the game,” said Levine. “Something like that just shows you how much the kids believe in one another and they don’t give up. Besides a walk-off win to get us into the tournament in our last game of the season in 2019, this was as exciting a win as I have ever experienced as any sort of coach here in Everett.”

Sandwiched between the two victories was a 5-0 loss to GBL rival Malden last Wednesday.

“We were unable to get much going offensively,” said Levine. “We outhit them five to three, but some defensive blunders cost us a few runs early in the game and we were unable to recover.”

Starting pitcher Lara deserved a better fate on the mound. Alex went four and two-thirds innings in which he yielded just two hits and one earned run. Saia, Santana, Lara, Turilli, and Nick Gilbert all chipped in with hits for the Tide.

“It just wasn’t our day at the plate or in the field,” noted Levine. “I have liked our approach at the plate over the past few games and really think we are headed in the right direction as a team.”

Levene and his crew, who stand at 4-5 on the season, were set to take on Chelsea this past Monday and will travel to Lynn Classical today (Wednesday). They will host Lynn

English next Monday at Glendale at 4:00 and will travel to Somerville next Monday.

EHS BOYS TRACK REMAINS UNDEFEATED

The Everett High boys outdoor track and field team remained undefeated with an 82-54 victory over Chelsea last Thursday.

Leading the way for coach Jehu Cimea’s squad was junior Shane MacKenzie, who out-distanced a strong contingent of Red Devil rivals to capture first place in both the discus and the javelin.

Shane won the discus with a toss of 108’-8.5” (which was nine feet longer than his closest rival) and took the javelin with a throw of 117’-8” (which was 16 feet longer than his nearest Chelsea foe) to score 10 points on the day.

“Shane continued his outstanding throwing season with two more wins in the javelin and discus,” noted Cimea.

Junior teammate Jason Stark completed a sweep of the throwing events for the Tide with his victory in the shot-put with a toss of 38’-5”, which was a personal record (PR) for Jason.

The Crimson Tide dominated the field events, taking 22 of the possible points in the high jump, long jump, and triple jump.

Junior Khang Nguyen (18’-4.25”), senior Adail Costa Fernandez (17’-4.5”), and junior captain Jalen Jones (37’-1.5”) went 1-2-3 in the long jump, as did the trio of junior captain Jayden Prophete (5’-0”), junior Donald Michel (5’0”), and Jones (5’0”) in the high jump.

The duo of Costa Fernandes (39’-4”) and Jones (37’-1.5”) went 2-3 in the triple jump.

Senior captain Shinay Aristhene led a Crimson Tide sweep in the 110 high hurdles with a PR of 17.9, followed by teammates Michel (with a PR of 18.2) and Owen Beauvil (with a PR of 18.8).

Shinay also took second place in the 400 hur-

dles with a clocking of 1:05.2 to tally eight points on the day.

Other first-place finishers for Everett were: Senior Anthony Cooper in the two-mile run in 11:58.5; freshman Kayshaun Eveillard in the 400 dash in 53.1; and senior Matth Telson in the 800 in 2:14.2

Adding three points with second-place finishes were: senior captain Samuel Desir-Mafaouana in the mile (5:23.8); junior Jeremiah Jeanlouis in the 100 dash (11.9); and Jones in the 200 dash (23.9).

Contributing single points with third-place efforts were: senior Fludjy Moise in the 400 dash (55.4); sophomore David Huezo-Erazo in the two-mile (13:18.9), sophomore Elijah Lassiter in the 400 hurdles (1:05.4); and Jaiden Williams in the 200 dash (24.2).

The Crimson Tide quartet of Eveillard, Williams, Jones, and Prophete won the 4 x 100 relay with a clocking of 46.2, easily outprinting their Chelsea counterparts, who finished in 51.1

“This was a great win by the boys’ team to continue their winning streak and to stay undefeated in the season,” said Cimea. “This team, when they’re down, they never say down. When everything was going wrong for us to start the meet, we got up and kept fighting and it showed in this meet.

“The meet changed for us once we got to the 4x100,” Cimea added. “That win changed the momentum of the meet in our favor.”

Cimea and his crew, who now are 3-0, sought to keep their undefeated streak going when they took on Lynn Classical yesterday (Tuesday). They will trek to Lynn English next Tuesday.

DESRAMEAUX SETS NEW EHS MARK IN DISCUS

Junior captain Darrynn Desrameaux broke another EHS school record, this time in the discus, with a throw of 92’-8”, easily topping the previous mark

of 90’-5”, to lead the Everett High girls outdoor track and field team to an 84-41 victory over Chelsea last Tuesday. Darrynn now holds two EHS records, having established a new standard of excellence in the shot-put two weeks ago.

The Lady Crimson Tide captured first place in nine more of the 13 individual events: Junior captain Suzanne Maharjan in the two-mile with a personal record run of 15:47.7; senior captain Nyla Crowder in the 100 dash with a sprint of 13.5 and in the high jump; senior captain Luca Jean Noel, who led an EHS sweep in the mile with a time of 7:19.2; junior Victoria Macao in the 400 dash in a clocking of 1:12.9; sophomore Milena Antonio, who led an Everett sweep in the 800 with her time of 3:07.8; sophomore Yelsa Garcia in the 200 with a dash of 26.4; junior captain Nicole Brandao in the long jump with a leap of 13’-8.75”; and junior Malaica Guillaume with a PR of 30’-6” in the triple jump

The Everett quartet of senior captain Ida Bittaye, Garcia, senior Jessica DeSouza, and Crowder also won the 4 x 100 relay with a clocking of 56.2, which was 3.7 seconds faster than their Chelsea counterparts.

Adding three points to the Everett scoresheet with second-place performances were: Macao in the javelin (69’-8”); junior captain Latla Betancur-Cardona in the shot (30’-2.5”); Bittaye in the long-jump (a PR leap of 13’-5.5”); freshman Isabella Pimenta in the 200

dash (27.2); sophomore Sonia Flores in the 800 (3:20.4); Brandao in the 110 hurdles (a PR of 18.3); junior Tiffany Escobar in the mile (7:24.8); and sophomore Zylle Cannon in the 100 dash (14.2).

Contributing single points with third-place efforts were: Guillaume in the 400 hurdles (1:26.9); junior Nicole Ramos Fonseca in the mile (7:52.4); Bittaye in the 110 hurdles (a PR of 19.2); freshman Casey Martinez in the 800 (3:21.2); and junior Tina Allen in the javelin (66’-5”).

EHS SOFTBALL CLINCHES SPOT IN STATE TOURNEY

The Everett High softball team punched its ticket for a Journey to the Tourney with a pair of victories this past week over Greater Boston League (GBL) opponents and a non-league triumph over O’Bryant High.

In a 17-5 victory over Malden last Wednesday at Glendale Park, the Crimson Tide jumped out to a 4-0 lead in the opening inning, keyed by a three-run homer by Kayley Rossi.

Everett made it 7-0 with three more markers in the second thanks to an RBI double by Kristi Skane (that scored teammate Emma Longmore, who had singled) and another double by Ashley Seward (that brought in Emilia Babcock, who had sin-

gled, and Skane).

Malden struck back for four runs in the third on the strength of three hits and three errors by the Everett defense.

“Defensively, this was not our inning,” said EHS head coach Stacy Poste-Schiavo. “We dropped routine fly balls and balls that bounced away from us.”

However, the Crimson Tide put the game away with six runs in the fourth to move out to a commanding 13-4 advantage. A solo home run by Babcock, a three-run blast by Gianna Masucci, and a two-RBI double by Longmore did the damage.

The Everett long-ball barrage continued in the fifth, with Seward delivering the roundtripper. Masucci also hit what would have been a homer, but she was held at third by Poste-Schiavo, thereby delaying the onset of the mercy rule, to enable some more Everett hitters to get a chance at the plate. The inevitable finally occurred when Jules Curran came through with an RBI double for the 17-5 finale.

Skane earned the win, tossing all five innings in which Kristi struck out six, walked one, allowed six hits, and yielded three earned runs.

“Kristi pitched great,” noted Poste-Schiavo. “We had one bad inning defensively, but we got right back up to the plate and made up for it.”

Leading the stat sheet for the Crimson Tide were: Emma Longmore 3/4 (2 singles and a double, 2 RBIs); Emilia Bab-

Historian Puleo presents his new book ‘Dark Tide: The Great Molasses Flood of 1919’

Historian Stephen Puleo presented his non-fiction book, “Dark Tide: The Great Molasses Flood of 1919,” during the April 13 Author Talk at Parlin Memorial Library. Puleo explained the social, political, and economic circumstances that contributed to the industrial accident. Twenty one people were killed, 150 were seriously injured, and 25 horses died in the disaster that resulted in massive property damage in the North End.

“It was a dramatic narrative,” said Puleo. “The tank was rushed to completion and leaked from day one. It was a landmark court case. All of the major issues the United States was dealing with in the early part of the 20th century touched this flood story in some way.”

The molasses tank, owned by US Industrial Alcohol, was erected in January 1916, when WWI was underway. Over 90% of the molasses stored in the Boston tank was processed into munitions. The raw, molasses substance was processed into the material that was refined into the industrial alcohol used in the production of explosives.

“This was a protected war industry during this time,” Puleo noted.

In “Dark Tide” Puleo mentioned the anarchist movement, when protestors were blowing up munitions plants and government buildings. The cornerstone of US Industrial Alcohol’s defense was that anarchists set a bomb in the tank; and that they should have been absolved of all liability. US Industrial Alcohol lawyers were unable to provide evidence of an explosive device.

Forty thousand people lived in the one-square-mile of inhabitable space in Boston’s North End. During this period, the community was 98% Italian. More than half of those Italian residents were not US citizens, and could not vote on the affairs in their own neighborhood.

“When the tank is sited on the Commercial Street waterfront – in one of the most congested neighborhoods in the entire country – there was barely a whisper from residents, even when the tank began to leak. For the most part, Italians kept their heads down and worked.”

The molasses tank was built in an area that included carpenter and blacksmith shops, a fire house, and stable for municipal horses. Rum, leather, and

produce were exported from the Commercial Street wharf to Europe.

The receptacle did not require a permit, and its construction was hastened to be ready for a molasses steamer ship that was arriving from Cuba in January 1916.

Boston’s molasses tank was located where a softball field and bocce court now stand in Langone Park. It was 50-feet-tall, 90-feet-wide, and held 2.3 million gallons of molasses. Fifty-foot streams of leaking molasses immediately began pouring from the sub-standard steel tank.

“One of the lawyers for the plaintiff said the weight was the equivalent of 13,000 Model-T Ford automobiles: 26 million pounds,” exclaimed Puleo. “The court case is a fascinating read. It was a time when being under oath meant something. You get a lot of great, candid answers of ‘yes,’ ‘no,’ ‘I did it.’”

“Dark Tide” examines the judge’s rule against US Industrial Alcohol in 1925, six years after the flood. It was the first ruling against a major US corporation.

“The entire relationship between government and business changed,” Puleo revealed. “The molasses flood case changed that relationship. There are more laws and regulations imposed by the government on businesses. Almost everything about building construction standards today is a result of the Boston molasses flood.”

There were 1,000 witnesses in the case, and 25,000 pages of testimonials.

The tank was declared for use after only being filled with six inches of water to test its durability. It would groan after molasses deliveries; and was repainted from a steel blue to a brown-red in an attempt to camouflage the leaks.

When the tank collapsed at 12:15pm on January 15, 1919, molasses gorged down, sending a 35-mile-an-hour wave of liquid along Commercial Street.

“It scoured Commercial Street, and rebound off of Copp’s Hill toward Atlantic Avenue,” Puleo detailed. “If Copp’s Hill had gone the other way, there’d have been thousands of deaths. It was a small tidal wave, picking up everything in its path – carts, people, and the overhead train trestle.”

Several firefighters were trapped for four hours under the firehouse during the flood, struggling to keep their heads above the



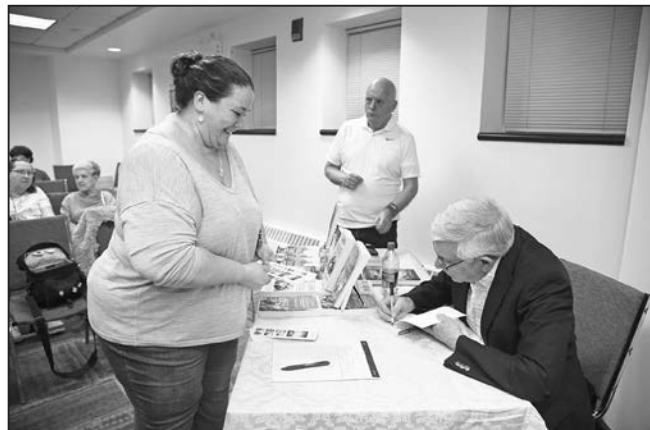

molasses before inevitably smothering. Two 10-year-old children of Italian immigrants also perished during their school lunch breaks. They had been collecting firewood and scooping molasses that had pooled on the ground.

The first floors and basements of the homes and businesses across the street from the tank were completely flooded. It took six months to clear the molasses and rebuild the

overhead train trestle that connected South Station to North Station. Firefighters pumped millions of gallons of salt water from Boston Harbor to clean the streets, washing most of the molasses back into the harbor.

“It was a surreal scene,” stressed Puleo about the devastation.

“Dark Tide,” published in 2003, is celebrating its 20th anniversary this year; and is often referenced in

high school and college curriculums locally and nation-wide. The Great Molasses Flood was one of the largest lawsuits in Massachusetts history, and is also a popular case study among judges and lawyers, as well as engineers.

Puleo is a professor at UMass Boston, and has taught history at Suffolk University. He was an award-winning newspaper reporter for the Boston Globe, American History

Magazine, and Politico. Puleo, who was born in Everett, is the author of seven books.


Puleo’s presentation was supported by the Friends of Everett Public Libraries, the City of Everett, and the Everett Cultural Council. It was described as the most successful Author Talk in years by reference librarian, Kathleen Slipp.

cock 2/4- (1 single and HR); Kristi Skane-4/4 (3 singles and 1 double, 1 RBI); Kaylee Rossi -2/4 - (1 single and HR, 3 RBIs); Ashley Seward- 3/4-(single, double, HR, 2 RBIs); and Gianna Masucci-2/3-(2HR, 3 RBIs).

Last Thursday, Poste-Schiavo and her crew trekked to O’Bryant High in Boston and came home with a 12-2 triumph that clinched their spot in the post-season state tournament.

TOUGH LOSS FOR EHS BOYS VOLLEYBALL VS. MALDEN

The Everett High boys volleyball team played hard, but ultimately came up short in its contests last week with Greater Boston League rivals Medford and Malden.

Last Monday, the Crimson Tide fell to the Medford Mustangs in straight sets.

“Henrique Franca, our leading hitter, missed his third game in a row,” said EHS head coach Michael Fineran. “Steve Flores and Dawens Germain also missed the game, but we have the depth to overcome those absences.”

In the first set, senior captain Dimitar Dimitrov, who moved to outside hitter from his normal right side spot, had three of his five kills. Sophomore middle Jefferson Umana also had three kills in the set.

But a string of serves from Medford in the middle of the set stretched a two-point lead to an eight-point lead, putting the set out of reach. The Tide clawed their way back to make it 20-17, but ultimately fell, 25-19.

In the second set, Everett proved unable to generate any momentum. The Tide earned zero points on serves and could muster only four kills and 12 points. However, Fineran’s crew fought hard in the third set before falling by a score of 25-21.

Umana had two digs and two blocks. Junior Andrew Linhares had an

ace, a block, and two kills in the set, and junior Nischal Tamang came off the bench to earn three kills and a block. “I liked how we bounced back in the third set, which was tight to the end,” noted Fineran.

The Tide next engaged with the Golden Tornadoes of Malden.

“We had a good week of practice after that match to regroup and work on our game,” said Fineran. “Tuesday especially had high intensity, so I had a feeling that we would play well against Malden, one of the top teams in the league.

“But it didn’t start out well for us. We had Franca and Flores back, but we played nervous and sloppy,” the coach continued. “We hit the first serve of the match out, and then found ourselves down 10-3 after the first two minutes.”

The Tide eventually found their footing, with a pair of kills from Franca and Umana each, but dropped the opening set, 25-12.

However, the second set was a different story. Linhares had three blocks and two kills, Franca had three kills and a block, and Flores had a kill and two digs as the teams traded points throughout the set. In the third set, Everett overcame four missed serves -- all of them coming when the score was tied or Everett was ahead by one -- to force a fourth set. Senior co-captain Ro-

berto Brizuela anchored the back row that minimized Malden’s attack. Franca had three kills, Linhares had two kills and a block, and Umana had two kills.

Umana was a clutch performer behind the service line. He hit all nine serves in, including six in a row, that pushed a 19-18 lead to 24-18, from where the Tide would go on to take the set, 25-19, to deadlock the match at 2-2 and force a decisive fifth set.

“We weren’t satisfied just taking a set from them,” said Fineran. “In the fourth set, we had eight kills from Umana, Linhares, and Franca en route to a 25-23 win.”

In the fifth set, kills from sophomore setter Dantae Bauer and Dimitrov helped Everett take a 4-1 lead. Tamang and Flores kept a number of plays alive with great defense. Linhares had a kill and a block, and Franca had two more kills. But with the game tied at 10-10, Everett hit a serve out and hit the next serve out as well, giving Malden triple match point at 14-11.

However, Everett was called for a double-touch on the final play, a disappointing end to a spirited match.

“This match was a microcosm of our season so far,” observed Fineran. “We make mistakes and struggle at times, and then we turn it on and show that we can hang with anybody. We are halfway through the season, and if we want to play in the state tournament, we will need to be that stronger,

tougher team far more consistently than we have been so far.”

Fineran and his crew play at Lynn Classical today (Wednesday) and will host non-league rival Pioneer Charter on Friday and Lynn English on Monday. They will travel to Somerville next Wednesday.
