Front Door to luxury

Encore Boston Harbor ends Lower Broadway's history of being 'back door to Boston'

The opening ceremonies on Sunday morning, June 23, quickly became a spotlight for Mayor Carlo DeMaria, who rejoiced in being able to tell the large crowds assembled to celebrate the opening that Lower Broadway is no longer Boston's back door, but rather the front door to Everett.

While other speakers made excellent points on what was an historic day in the state and the City, it was those words of Mayor DeMaria that hammered home

"To the residents of Everett, Everett United and the 86 percent of the people on a Saturday who took the time to vote 'yes' for a resort in our city, this truly is an amazing day," he said. "For those of you who suffered through Monsanto and other big industries that polluted our properties and got us all very sick, I want to thank you for all you did; people like (the late) Mary Bagarella and others. No longer when you drive through Everett will you smell gas and Sulphur and oils, but you'll smell flowers and trees.

We will no longer be the back door to the City of Boston. We will now be the front door to the City of Everett."

And it was true.

As he spoke on what was an extraordinary summer morning, the new trees on the Porte Cochere rustled in the wind, and songbirds flew in and out of the crowd assembled for the opening from tree

There were no songbirds on the site five years ago, quite certainly.

And beyond the Encore site, there still exist areas up and down Lower Broadway that look more like the past than the present at 1 Broadway (the Encore address).

DeMaria said that will also change, and he said he plans to continue partnering with Encore and others to make that full change.

"This was always going to be a Wynn," he said. "There was never any dispute, and that's because years ago a great man promised me that their company would be part of this community – that we

Shaq highlights entertainment business at Encore opening

When you think of night life in Everett post-June 23, think of a 7-foot-tall retired NBA star who can spin tunes as skillfully as he formerly shattered backboards.

On Thursday, June 27, NBA Hall-of-Famer (and onetime Boston Celtic) Shaquille O'Neal will headline the Memoire nightclub at Encore Boston Harbor, bringing his ultra-popular DJ Diesel act to Everett.

O'Neal has had an existing relationship with the Wynn team in Las Vegas, appearing there at their properties numerous times. Forbes magazine called him the most successful DJ on the planet since launching his newest career in 2017. Now, that DJ relationship is likely going to trickle into Boston on a somewhat-frequent basis as he joins the new acts coming

to Everett. "We have a private event

next weekend where we have invited guests coming in for dinner and a concert with Earth, Wind & Fire," said Encore President Bob DeSalvio, highlighting the entertainment options that are to come to the resort. "We have the week after that Paul Anka doing a private concert for our VIP guests as well. We're going to have our first sporting event July 12 working with Ken Casey and Murphy's Boxing for a championship boxing event right in our Picasso Ballroom. We're going to continue to look at other opportunities us-

ing our current 37,000 sq. ft. ballroom facility.' Such stars and small shows

are going to be relatively common at the Encore as time goes on, officials said. At the same time, Encore

will not be hosting large-capacity Las Vegas-style shows at in-house theatres. In fact, they are not allowed

such a thing.

The state's gaming law was very specific in spelling out just how many guests could be at an on-site show or event, hoping not to cannibalize the existing theatre and event spaces already in Boston. With that, Encore had created codified relationships with venues like the Wang Theatre and the TD Garden. Those two venues and others will play large in concert with the Big Night Entertainment sponsored Memoire Nightclub on the property.

DeSalvio said

Councilors talk traffic, parking in wake of casino opening

At Monday night's regularly scheduled City Council meeting, Councilors presented a number of new items that would strengthen the City's parking and traffic infrastructure in the wake of this past weekend's opening of Encore Boston Harbor.

Parking

An item introduced by Councilor John McKinnon proposed that the City consider a citywide 24/7 residential parking ordinance that would include weekends.

Twenty-four-hour resident-only parking stickers are already in effect for the streets

surrounding Lower Broadway, and the administration is choosing to take a "wait and see" approach when it comes to other areas. Other possible areas that have been identified are Wards 1 and 6.

Councilor McKinnon told the Independent that he was worried that, despite Encore's efforts to educate visitors about public transit options, out-of-town vehicles will still flood residential streets throughout the city, making it impossible for residents to park in their own neighborhoods.

He said that a 24/7 parking

Maddox: Lower Broadway will be a destination 'district' in 10 years

As the ribbon was cut on the \$2.6 billion Encore resort casino, plans were already in the works to add more and make the casino less of an island and more of a centerpiece to an entire entertainment district along Lower Broadway.

Wynn Resorts CEO Matt Maddox told reporters on June 21 at the Encore media day that they don't intend to stop at the boundaries of the casino site, and they believe others will follow them.

Maddox said they own 11 acres of property across

from Encore that amounts to 82 parcels they've purchases over the last four years. That property is now a temporary parking lot, but there are much bigger plans in store.

"We want to work with the City to create an entertainment district," said Maddox. "It's not all going to be our company, but we want to work side by side with local developers. Our idea is to continue to re-design this area so it's known as 'the' entertainment district in the northeast. You build this anchor and others

Host Community Agreement payments now a focus for City

The City's Host Community Agreement (HCA) was signed and reviewed by residents such a long time ago, but with the opening of Encore on June 23, that agreement was triggered into action – and it will mean \$25 million in payments to the City over the next fiscal year.

Chief Financial Officer Eric Demos said the HCA is now in effect, and he is actually expecting a \$440,000 payment within the next 30 days for the eight days the casino

was open during the current fiscal years. On July 1, a new fiscal year begins and the larger payments in the HCA will take effect.

The two big pieces of that agreement include a \$5 million annual payment for the Community Impact Fee, a payment that goes up by 2.5 percent every year.

The second, larger payment is a \$20 million Payment in Lieu of Taxes (PILOT) that the resort will pay annually to the City. The agreement is

MAYOR CARLO DEMARIA DESERVES THE CREDIT FOR THE RESORT/CASINO

Seven years ago on a cold November afternoon, Steve Wynn came to Everett at the invitation of Mayor Carlo DeMaria to look at a possible site for a casino. The land was an old industrial site on the Mystic River that was classified as a Brownfield.

Many elected officials and residents thought that DeMaria was naïve about having a casino in Everett since he was going against a competing casino in Revere and East Boston that was heavily favored by many area politicians.

However, DeMaria never took his eyes off the goal of having a world-class casino in Everett. He worked with the Everett United committee in helping get the 86 percent voter approval for the casino. He testified before the Massachusetts Gaming Commission in support of the casino in Everett rather than Revere. Over the next seven years, every construction or corporate hiccup that happened concerning the casino, naysayers were the first to ridicule DeMaria, saying that the casino would never happen in Everett. Even as recently as four weeks ago these naysayers were still saying that MGM would buy the casino in Everett or that it was a sure bet that the license would be pulled by the Gaming Commission.

Sunday proved these naysayers wrong again, and DeMaria right, as the casino officially opened on a perfect summer's day at 10 a m

This casino is probably the greatest single development in the history of Everett, and there is just one man who had the vision and determination to get this project to completion for the residents and taxpayers of Everett and that man is DeMaria.

Some of the benefits that DeMaria fought for that this project will bring to the city of Everett are:

- •Good paying jobs for 700 residents
- •Greater access to the waterfront
- •A great corporate neighbor
- •And more than \$30 million annually for the city tax coffers to use for parks, police, infrastructure repair, firefighters and schools to mention just a few.

While many people would be content to sit back and celebrate the completion of the casino, DeMaria is wasting no time in now setting his sights on improving transportation in Everett.

We feel it is appropriate to say thank you to Mayor DeMaria for his vision and work on this casino that will make Everett one of the premier communities in Massachusetts.

Regardless of how one may feel about the issue of immigration, legal and illegal, we would hope that every American would agree that the policy of separating children from their parents, and then detaining those children in facilities that are not fit for animals, represents a stain on our national consciousness that is evident for all the world to see.

These children, who range in age from toddlers to young teens, have been treated as less than human by our government. Some have died while under the care of the Border Patrol; others have become sick and malnourished. All will bear the psychological scars for the rest of their lives of being held in makeshift jails in conditions that are nothing less than appalling.

America is supposed to be a beacon of light in a world of darkness, a place where everyone, regardless of race, creed, or national origin, is treated with dignity and respect.

However, from our nation's inception, all too often we have failed to live up to the noble words in the Declaration of Independence that, "All men are created equal."

Slavery was embedded in our Constitution; segregation was legally permissible for almost 100 years after the Civil War; Native Americans were massacred and forced onto reservations; women were second-class citizens and not allowed to vote until 1919; and Japanese-Americans were interned during WWII.



Wynn, Encore officials hail DeMaria for his vision for Everett

Robert DeSalvio, president of Wynn Boston Harbor and Matt Maddox, CEO of president of Wynn Resorts, each hailed Carlo DeMaria's vision for Everett during the pregrand opening press conference Friday at the \$2.6 billion resort/casino.

"Mr. Mayor, I want to say, thank you so much," said De-Salvio in front of a gathering of local and national media. "We know that the team here could not have done this without vou."

Maddox also offered praise to DeMaria in his remarks.

'This would have never occurred had it not been for the vision of Mayor Carlo De-Maria and the city of Everett," said Maddox. "When I actually came to Everett about seven years ago in the November of 2012 and saw this site for the first time and met with the mayor, he laid out a vision for urban renewal and for an entertainment district right here where we standing."

Maddox said it was "really extraordinary to sit in City Hall in Everett and hear the passion and everything he [DeMaria] had dedicated to this and how he believed he could make this

"And it was at that moment that our company thought, 'this could be the perfect partner to bring to the state of Massachusetts a five-star, integrated resort," reflected Mad-

Maddox then called upon the mayor to expound on the vision he had for the site where the incomparable Encore resort/casino now stands in the

"I used to bike to Northeastern as a kid and always drive by the Monsanto chemical plant," recalled DeMaria. "It was empty. It was barren."

"Fast forward, I become mayor and try to get some economic development going in my community," said De-Maria. "I went to the secretary of economic development and said, 'I really want to do something great for my city.' I want to get access to the waterfront."

DeMaria said the secretary suggested that he put together a master urban renewal plan. The mayor initiated a master plan and held meetings with residents, who wanted to see a hotel, a marina, and active use of the waterfront.

"That report was released and I got a call from the Wynn team and the rest is history," said DeMaria. "There were some other people who wanted this site, but I said I wasn't interested. When I heard the name Wynn and the organization, I said, 'this is the company that I would love to do business with."

DeMaria said the early discussions with the Wynn organization were the source of much optimism.

"From Day 1, the conversations with Mr. Maddox and Mr. Wynn at the time, and the team, they were always positive," said the mayor. "They bought in to my vision that we forecast, that this is a great area of opportunity for our residents. They said, 'Mayor, we want to be a partner, we want a true partnership.'

"And that's what it is, it's actually a true partnership - and it's been wonderful," added DeMaria.

DeMaria said the prospects for the area and the city continue to grow.

'We're looking at things like gold-standard BRT (bus rapid transit) in the city of Everett, a \$25-30 million pedestrian footbridge, and connecting our bike paths from Gloucester and Nahant all the way in to Everett – and that's going to be a realization," said DeMaria.

He applauded Wynn for building a beautiful park on the Malden River. "It is a wonderful facility for the city of Everett. My residents couldn't be happier."

And just as the mayor anticipated and Encore Boston Harbor followed through on its pledge, there are many jobs for residents of this city and adjacent communities.

"Six hundred or seven hundred Everett residents are working here and I get a chance when I come here, to see them - and they're beaming. They're so happy. They have a great job for a great company. That's amazing. To get a five-star resort – but not only that, a company that really treats their employees with love and care. You don't really find that in many industries, but you find it with this organization."

The mayor's remarks were impressive and well received. But the city's chief executive was just warming up. His speech at Sunday morning's grand opening ceremony, in which he vividly showed the emotion of what the historic day meant to him, his wife, Stacey, his city and Everett residents current and past - was even more extraordinary.

ated by the Encore team; it was created by the City of Everett," said the mayor. "We looked at this whole area. You see the buildings coming down across the street - the used car lots and the scrap yards. We were defined for many years as that gritty industrial city that had tough guys that play football. We still have tough guys that play football, but we're not longer a gritty city. We're a city on the move and get a little hotel business and make this a vibrant district.'

Maddox was, in fact, the first person from Wynn Resorts to visit Everett and the old Monsanto site. He said after an initial meeting at the site, he brought members of the team and they found the mayor's vision for the district very appealing.

"He had a vision for Urban Renewal and an entertainment district," said Maddox. "It was exciting to sit in City Hall (in 2012) in Everett and hear that plan and everything they did to create it and he really believed it could happen. At that point, our company believed we had found the partner we needed to bring to Massachusetts and integrated resort."

Maddox told reporters on Friday he was confident about the location and the plan to move forward across the street on what was previously described as a hotel/entertainment resort with about 800 rooms.

"You learn as you go," he said. "We feel very confident about the location and the relationship with the City and what this property will be and what it's able to generate in the northeast. What you find out is what you're missing. You don't know what you're missing right away. We'll think about developers to partner with, who we can partner with in the city. We'll look at hotels, apartments, and what it is that needs to go here. We'll really take our time to work with the right people and the City to come up with a comprehensive master plan to create one of the best entertainment districts in the north-

Councilor John Hanlon took a point of personal privilege to congratulate City Clerk Sergio Cornelio for having been appointed by the Massachusetts Town Clerks Association (MTCA) as a member of its Legislative Committee, which drafts the MTCA bylaws and writes opinions that go before the state legislature. Cornelio was also selected as one of three members of the MTCA Board of Directors and is currently serving as a lobbyist in the interests of the organization.

The councilman praised Cornelio for what he has been able to achieve in less than two years as City Clerk, adding that Cornelio is also the youngest clerk in the state.

"This is a proud moment for him, for the City of Everett and for the City Council,"

•Approval of CIP Budget

On Monday, June 10, Council held a special meeting to hear a presentation by the administration on its Capital Improvement Plan (CIP) for Fiscal Year 2020, in which it requested a total of \$16.4

million for general requests through bond authorization across the City's Police, Planning & Development, DPW Facilities Maintenance and DPW Highway Departments, plus an additional \$2.5 million annually for fiscal years 2020 to 2023 for water and sewer.

At the June 24 meeting, Council voted to approve all of the funding.

Councilor Fred Capone called Demas "a tremendous asset for this community."

"Mr. Demas is an absolute asset to this city and us," Councilor Anthony DiPierro echoed. "I'd vote for you for

The Council had previously invited Demas to appear at Monday's meeting in order to update Council on any recommendations that have been made by the School Review Commission.

Demas told Council that a

draft had been received and was currently being factchecked. He reported that the Council should be receiving a copy of the recommendations sometime over the summer.

•Sale of Everett Memorial Stadium Councilor Stephen Sim-

onelli invited Mayor's Chief of Staff Kevin O'Donnell to update Council on City's sale of Everett Memorial Stadium.

Specifically, Councilors wanted to know how a sale of the stadium would affect the World War II memorial located out front. The monument features the names of Everett residents who fought and died in the second World War and Councilors want to ensure that it continues to be a well-maintained and easily accessible monument and point of community pride.

"The memorial is an important piece of this discussion," said O'Donnell. "There are veterans here on this Council. I don't think there's anyone in this chamber that doesn't have a family member that's a veteran.

"If we're going to go forward, I'm sure there'd be quite extensive conversations with respect to [the memorial]," he continued.

He also expressed that a robust community input process would be undertaken to determine any future development of the stadium. A plan is in the works to move the sports stadium from the Parkway to the new RiverGreen park on Air Force Road.



Council: Bluebikes 'a disaster', 'can't stay where they are'

At Monday night's Council meeting, Councilors expressed concern over the City's recent rollout of the Bluebikes program, and the discussion resulted in a unanimous called for an emergency meeting with Mayor Carlo DeMaria and the representatives of Bluebikes.

In an effort to reduce vehicular traffic, the City recently entered into a contract with Bluebikes, a bike-share program that allows riders to rent and return bicycles at numerous locations. Councilors were told that they would be involved in the Bluebikes launch process, until they noticed docking stations cropping up all over the city.

ping up all over the city.

Councilor Fred Capone wanted to know the terms of the contract that the City entered into with Bluebikes and specifically whether or not the company will be required to pay a fee for profiting off of its presence in Everett and taking up space on public sidewalks.

on public sidewalks.

The councilman lamented that the City had not taken such an approach when it began working with Lime, another bike-share program in Everett, and considers it "a missed opportunity."

"We could have done good things with that money, something tangible and beneficial for

the community," he said.

The councilor spoke favorably about bike-share programs in general, saying "it serves a wonderful purpose because we want to get cars off the street."

He also cited the health and environmental benefits of biking, but said that no company should be able to come into the city and profit off of public use without giving back to the host community.

Councilor Capone also wanted to find out how the docking station locations had been determined and why Council was not made a part of this process.

He said Bluebikes had installed a docking station of 15 bikes and a large advertisement in front of two residential properties along Main Street, a move he said has property owners irate.

Councilor Michael Mc-Laughlin shared his colleague's concerns, adding that some of the locations of the docks have bikes backing out straight into oncoming traffic, which could

bikes backing out straight into oncoming traffic, which could lead to cyclists being run over.

"The Bluebikes rollout was a disaster," he said. "They just

dumped them. Who came up

with the idea to put them where

"We could have done good they put them? Not one of them

makes sense."

"This program needs to halt immediately until we come to these chambers and have a discussion with Bluebikes about who gave them permission to put them where they're located, who came up with the map of where they're going to be located, and how we're going to move them because they can't stay where they are," said the councilor.

Councilor Stephen Simonelli agreed with taking immediate action.

"This should be shut down tonight," he said through his spokesperson. "It's a nuisance and a public safety issue. If someone pulls out of that bike rack and gets killed, are we responsible?"

"We were told we were going to be part of the process and we weren't," said Councilor Capone. "We're requesting that no more bikes be put out until we discuss it."

The matter was referred to the City Clerk, who will be in charge of scheduling a special meeting of the Council's Committee of the Whole along with representatives from the Bluebikes, the Mayor's Office and the Planning Department.

"Seven years ago I was standing here on this site with the mayor, just us two, and there wasn't a blade of grass on the site," he said. "Now there are 1,000 mature trees, 50,000 flowering plants, tens of thousands of shrubs and a




THE ENCORE BOSTON HARBOR WATER SHUTTLES STARTS SERVICE

The Encore Boston Harbor water shuttles kicked off service officially on Sunday morning, June 23, bringing guests to the casino from the Seaport via Long Wharf. The water shuttles were designed and constructed at Boston Boat Works in Charlestown, and have the advantage of being lower than the Alford Street Bridge so they don't send the drawbridge up every time they pass through.

Each of the four shuttles costs about \$1 million and feature a stabilization system for rough days on the Harbor. Encore and Boston Boat Works officials said they believe the shuttle system could be a spark to help truly initiate water transportation into the area's mosaic of options.





MGC officially approved Encore Boston Harbor for grand opening

The Massachusetts Gaming Commission (MGC) issued regulatory approval June 21 for Encore Boston Harbor's public opening on June 23.

Under the close observation of MGC staff, Encore Boston Harbor successfully completed test play nights on June 17, June 19 and June 20. MGC staff monitored and evaluated the practice events for strict adherence and compliance with state law and MGC's internal control regulations. MGC's Investigations and Enforcement Bureau (IEB), the Information Technology Services Division (ITSD) and the Finance Division worked together to supervise gaming systems and pro-

cedures to ensure the integrity of the games, compliance with regulations and overall adherence to Massachusetts' strict gaming standards.

"As Encore Boston Harbor prepares to open its doors, the MGC remains focused on ensuring that our policies and procedures protect the integrity of the industry and safeguard fair play for patrons," said Commissioner Eileen O'Brien, who observed the test nights and was delegated by fellow commissioners to issue opening approval. "I want to commend the dedication of the IEB, ITSD, finance and all additional MGC staff for their commitment to the highest standards of regulatory compliance."

At a June 12 public meeting, the five-member Commission authorized the test nights and determined that Encore Boston Harbor demonstrated "material compliance" with the gaming law, commission regulations and the terms and conditions of its license. The MGC's extensive review of the overall project acknowledged that Encore Boston Harbor had met or exceeded requirements in areas including construction commitments, regional marketing and economic development, diversity, employee and vendor licensing, responsible gaming and numerous other license obligations. 
Encore officials said they believed that the thousands that came bought into the alternative transportation plans - a campaign entitled 'Why Drive?'
