Everett High School senior Betania Zelalem has received a National NCWIT Award for Aspirations in Computing (AiC). The award, powered by the National Center for Women & Information Technology (NCWIT), recognizes 9th-12th grade women, genderqueer, or non-binary students for computing-related achievements and interests, as part of an effort to encourage a diverse range of students to choose careers in technology.

Four hundred award recipients were selected from high schools across 43 states and all U.S. overseas military bases for their outstanding aptitude and aspirations in technology and computing as demonstrated by their computing experience, computing-related activities, leadership experience, tenacity in the face of barriers to access, and plans for post-secondary education.

All recipients receive

Councilors take no

action on resolution

Participation part of the City Council meeting on Monday night calling for the resignation of Ward 3 Councilor Anthony DiPierro, citing the racist meme that appeared on his Instagram account, City Councilors later in the meeting could not agree to approve a resolution condemning racism and affirming the Everett City Council's commitment to diversity, equity, and inclusive education and practices.

The resolution was written by Councilors Stephanie Martins and Vivian Nguyen, and initially was signed onto by Councilors Stephanie Smith, Irene Cardillo and Richard J. Dell Isola, Jr.

However, after reading the preamble, Smith, Cardillo and Dell Isola asked that their names be removed as co-sponsors. "I will vote no on this,"

said Smith. "I condemn racism, (but) I don't call out my colleagues on the record." Councilor Michael

Marchese was irate over his name being listed on the resolution calling it "a cheap shot." "I have not said one

comment about anyone stepping down, and then throw this cheap crap at

hide nothing. This is really a cheap shot. All this does is divide the city. You should be ashamed of yourself."

Martins, in defending the resolution, said, "All racism is unacceptable and I am proud of what we worked on."

"This needs to be reworded," said Councilor Wayne Matewsky. "I hope that no one is a racist. This is a good city and it is not perfect. People have made a mistake. Where does it end?"

"This needs a lot more work," said Cardillo. "We need more than words, we need action." However, Nguyen re-

sponded, "It is important to mention names and specifics in the resolution." In the end, the resolution was referred back to the sponsors who have

the option to reword it and submit a revised resolution. The resolution reads as

DiDomenico announces Senate passage of \$1.65 billion supplemental budget

Sen. Sal DiDomenico and his colleagues in the Massachusetts State Senate passed a \$1.65 billion supplemental budget for Fiscal Year 2022 (FY22). The legislation makes investments in the state's long-term COVID-19 response; addresses staffing shortages in schools; provides support for home community-based services, assistance and protections for families experiencing housing and energy insecurity; funds winter road improvements; extends outdoor dining services as well as beer, wine and cocktails to-go, and provides for the resettlement of Ukrainian refugees in Massachusetts. Notably, the bill also would divest the state pension fund from Russian assets in response to the

Russian war in Ukraine. "Repeatedly throughout this pandemic, the Massachusetts Senate has demonstrated our commitment to investing in Commonwealth's most critical program and services, and this su plemental budget is no exception," said DiDomenico. "With this legislation, we prioritize our most vulnerable population, continue supporting our health care workers and education sector, and make key investments in our local infrastructure to help Massachusetts build back stronger. I would like to thank Senate President Karen Spilka and Senate Ways & Means Chairman Michael Rodrigues for

their leadership in moving our Commonwealth forward and prioritizing an equitable COVID-19 recovery."

Responding to COVID-19 To mitigate the spread of COVID-19 and ensure robust preparation in the event of a future variant outbreak, the bill invests \$700 million for the state's COVID-19 response. This funding would ensure the continued no-cost availability of crucial services offered to residents during the pandemic, including on-site testing, vaccinations, and treatment, as well as public health staffing needs resulting from COVID-19.

To further protect families facing housing challenges, the supplemental budget extends through March 2023 several protections for tenants experiencing COVID-19-related financial hardship, including extending the requirement that a court grant a continuance in an eviction case for nonpayment of rent when the tenant has a pending rental assistance application.

The supplemental budget also extends popular pandemic-related provisions including outdoor dining services, and beer, wine and cocktails to-go through April 2023. The legislation also extends COVID-19 related bonuses for members of the Massachusetts National Guard.

Responding to Russia's Invasion of Ukraine The supplemental bud-

get responds to the Russian Federation's February 2022 invasion of Ukraine and the subsequent violence against Ukrainian civilians. An amendment unanimously adopted on the floor of the Senate requires the Commonwealth's Pension Reserves Investment Management (PRIM) Board to divest any holdings from companies officially sanctioned by the Biden administration or incorporated in Russia. The supplemental budget also allocates \$10 million for the Office of Immigrants and Refugees to support the resettlement of international evacuees, including Ukrainian evacuees.

Housing and Energy Assistance

The supplemental budget includes several provisions relating to housing stability and support for individuals currently experiencing or near homelessness. The Senate proposal includes \$100 million for the Residential Assistance for Families in Transition (RAFT) program which provides eligible families with funds that they can use to keep their housing or obtain new housing. One amendment added to the budget on the Senate floor would increase the cap of the program RAFT \$10,000 for the remainder of the fiscal year. Another amendment clarifies existing law to ensure that in all eviction cases where the only valid reapayment of rent, that the tenant has access to protections. The supplemental budget also dedicates \$20 million to the Low-Income Home Energy Assistance Program (LIHEAP), which provides crucial assistance to families facing high utility bills. To increase oversight, the bill also directs the department of housing and community development to make detailed quarterly reports on the state's eviction diversion initiative.

The supplemental budget allocates \$2.8 million for rates at shelters for homeless individuals and also ensures that down payment assistance funds received from the Massachusetts Housing Finance Agency or the Massachusetts Housing Partnership will not be considered taxable in-

Health Care

& Mental Health The bill allocates \$346 million in federal American Rescue Plan funding for Home- and Community-Based Services (HCBS) resources to ensure that eligible Medicaid users throughout the Commonwealth are able to receive health care and medical services in their own homes or local communities. Alongside this investment, the bill also appropriates \$55 million in state resources to support reimbursement rates for human and social service providers that have also been doing crucial ic. To address the crisis of mental health care, the bill also dedicates \$10 million to suicide prevention and intervention services, focused on staffing and other resources at crisis centers, and the establishment of a statewide 988 suicide prevention hotline.

An amendment adopted to the supplemental budget allocates \$24 million of the state's American Rescue Plan Act (ARPA) funds specifically for the creation of new behavioral health and substance use disorder treatment beds.

Education

In response to reports of staffing shortages in public schools, the supplemental budget includes a provision authorizing the Commissioner of Elementary and Secondary Education to issue emergency educator licenses until 180 days after the end of the public health emergency. For private special education schools operating under Chapter 766, the budget allocates \$140 million to fill immediate staffing

needs. Other funding items of

- note include: • \$100 million for a new Winter Road Recovery Assistance Program for cities and towns to repair potholes and roads and bridges worn down by adverse weather conditions.
- \$20 million for Victim of Crime Act (VOCA) funding which ports no-cost counseling, advocacy, and intervention services to victims

Through the inventory process, each tree has been or will be numbered, pictured, identified by type, and listed by address. In the unusual situation where a tree is located under a power transformer, near power lines, or near water lines then the tree will be relocated to the closest possible position.

TOXIC MASCULINITY AT THE OSCARS

When we first heard the joke by Chris Rock that was directed at Jada Pinkett-Smith at the Oscars, we didn't get it. It was not until Will Smith stepped up to smack Rock that we grabbed our laptop to do a Google search for "G.I. Jane" and "Jada Pinkett-Smith" to figure out what the incident was all about.

We've admired Chris Rock and Will Smith throughout their careers, both on and off the stage.

But the behavior exhibited by both of them at Sunday's Oscars show was inexcusable.

Chris Rock's joke (which wasn't even funny) was obnoxious, in bad taste, and hurtful. Mocking a person with a disease (Ms. Pinkett-Smith suffers from alopecia) or a disability never is appropriate in any setting.

This sort of bullying behavior is a characteristic of many men. Recall for example, when our former president mimicked with his body language a New York Times reporter who has a physical disability.

Similarly, Will Smith's subsequent assault and battery upon Rock exemplified another variation of a uniquely-male noxious attitude in which men justify the use of their fists (or guns) either to salve their bruised egos or to get what they want by brute force (e.g., Vlad-

We have read in various media that some have attempted to justify Smith's criminal behavior on the grounds that he was defending his wife's honor. However, women are more than capable of taking care of themselves. They don't need a man to do so. That attitude prevails only in societies where women are treated like second-class citizens.

In our view, both Chris Rock and Will Smith should be banned from the Oscars until further notice. Their toxic masculinity has no place anywhere in our society, but especially on a stage as big as the Oscars.

RECALLING THE APRIL FOOL'S DAY BLIZZARD OF 1997

This Friday, April 1, will mark the 25th anniversary of the great April Fool's Day blizzard of 1997.

As often is the case when a major storm strikes, the forecasters had not predicted the extreme severity of the

We recall going to bed that night of March 31 and preparing to go to work the next day, only to wake up to discover that Mother Nature had dumped more than two feet (25.4 inches was the official total at Logan Airport) of heavy, wet snow on our area, making it the fourth-largest snowstorm in Boston history, exceeded only by the 27.5 inches in the President's Day blizzard of 2003; the 27.1 inches in the famous Blizzard of '78; and the 26.3 inches in the blizzard of February, 1969.

The storm was the biggest on record in the month of April and made April 1997 Boston's snowiest April ever, nearly doubling the previous record of 13.3 inches. It also set a record for Boston's greatest 24-hour snowfall in April.

We vividly recall waking up to the wonder of that morning. "Are we still dreaming?" was our first thought when we opened our front door, only to be greeted by a huge drift of snow that had been driven by winds that reached 70-90 miles per hour in many areas.

Ironically, that winter had been fairly uneventful (there had been only 26 inches of snow in total that winter season).

Although the storm essentially paralyzed the Boston area for that entire day, it was not a particularly dangerous storm. We recall a lot of downed tree limbs that were laden with the heavy, wet snow, which in turn brought down power lines in some places. The only deaths were the result of heart attacks by persons trying to shovel the heavy snow. In addition, there was no coastal flooding.

Our overall memory of the blizzard is the picture in our mind's eye of a Winter Wonderland amidst temperatures that reached the 50s by mid-day.

It was a joyful event, an unexpected day off from work (and back then, the internet was still barely a thing, so no one worked remotely). We took our young children sledding and walked around the neighborhood with our Golden Retriever, Jake, who loved the snow.

Yes, it was a ferocious, record-breaking storm. But for us, we always will have only warm memories of the April Fool's Day Blizzard of 1997, a particular point in time when we, and our now-adult children, were 25 years younger.

Ukraine refugees are coming

America has been good to help people and more are on the way.

Refugees from Ukraine are coming to America, up to 100,000 would be welcomed as recently announced by President Biden. The population of some communities will grow depending on where the federal government places these people. Since the passage of

the refugee act there are already over 3 million refugees in America. They are located throughout the United States with large populations in some towns and cities. A refugee is "a person

who is unable to return his or her country of origin because of a well-founded fear of persecution based on race, religion, nationality, political opinion, or membership in a particular social group." A refu-

country of resettlement and is eligible for federally funded cash assistance for up to 8 months. Refugees are resettled in the United States by the federal government and are afforded specific refugee assistance to help them rebuild their lives in America. This federal funding is limited in both duration and amount. It is important to note that most refugees arrive with very little in terms of possessions, beside a few bags of luggage, and if they are lucky, all of their family members.

All refugees arriving in the United States are entitled to 8 months of Refugee Cash Assistance (RCA) from the date of their U.S. arrival. The RCA amounts vary based on the size of the family: Single person (\$230/ month), Family of 2 (\$363/Month), Family of 3 (\$485/month), Family

gee legally resides in the of 4 (\$611/month), etc. If a family qualifies for Temporary Assistance to Needy Families (TANF), offered by the State Department of Health and Human Services, they will not receive RCA funds, but will immediately begin receiving TANF funds, which provide the same amounts of funds as outlined above for families (Refugee or American), yet unlike RCA, there is 5 year time limit to their receipt of funds which can be reviewed and extended depending on need. All TANF recipients must be participating in verified educational courses, volunteer placements, and/ or employment searches in order to access these funds. Source, Catholic Charities




A SHORT STORY ABOUT GROWING UP WITH AN UNFAIR ADVANTAGE.



MADELINE ENGLISH EIGHTH-GRADE STEM CLUB PLANTS TALL GRASS







The students of the Madeline English eighth grade STEM Club, along with Tom Philbin the City of Everett's Conservation Agent, are working to grow low and tall grasses, as well as wild flowers, with the use of seed tubes. This method (built by the students) allows the seeds to retain water and also hold the grasses in place. In addition to planting the low grass so far, they spread meadow seed at Rivergreen before placing fiber mats over the top, and staking them, in order to stabilize the steep bank to retain moisture and prevent erosion of the bank and seed. In the end, by planting these different seeds, this will result in the creation of a pollinator meadow.

Cabbage around the world

According to the website Spruce Eats, at least 400 types of cabbage exist around the world. However, most of us buy and use one of four varieties - green, Napa, Savoy, and red/purple. Some of us also add a supply of fermented cabbage like kimchi and sauerkraut to our pantries.

We usually have green cabbage in our crisper. Whole heads stored in a plastic bag will last for weeks. Just toss away any wilted or bruised outer leaves before use.

Red or purple cabbage

is great for adding color to raw or pickled dishes like coleslaw. When cooked, it will turn blue. This trait can be lessened by adding an acidic ingredient like vinegar or citrus juice to

the cooking liquid. Savoy cabbage is wrinkly, sweet, and grows as a less compact head. It is terrific to use as a wrap for stuffing and baking. You may want to buy it by the pound rather than the head when using it to replace green cabbage.

Napa cabbage is much lighter and perfect for eating raw and is the traditional choice for cabbage kimchi. We find it doesn't last as long as the green or red varieties but is part of many of our favorite Asian dishes.

A World of **Cabbage Eaters**

One Napa cabbage favorite of ours is Vietnamese Noodle Bowls or Bún Thịt Nướng, which means rice vermicelli with grilled meat. Like many thrifty meals, Napa cabbage plays a big part in this dish. It also stars inside delicious pork and cabbage dumplings, and moo shu pork we order from Chinese restaurants.

There are also many better-known dishes where cabbage was used to add bulk, nutrition, and flavor to dishes in areas where other vegetables

were scarce in winterfor example, stuffed cabbage rolls and sauerkraut and mushroom pierogi in Eastern Europe. Colcannon in Ireland uses cabbage and in Mexico, tacos are served with cabbage salsa.

Cabbage Tips

Cutting through a fresh, firm head of green or red cabbage is a job for a big sharp knife. Penny sometimes uses a cleaver. For the safest cut, consider lopping a bit off the side to give yourself a flat surface to cut across the core.

When you cut into a head of cabbage and don't plan to use all of it, save a couple of the least damaged outer leaves. We've found that the remaining

wedge lasts longer when wrapping the cut surface with a leaf held in place by a giant elastic band.

To reduce the unmistakable aroma of cabbage cooking, set out a small dish of white vinegar near your pot and add a teaspoon to the pot as you begin cooking. The longer the cabbage cooks, the more pungent the smell. Quicker cooking methods can help. You should also avoid aluminum pans, foil, and utensils. There is a reaction between aluminum and cabbage that increases the odor and can





MBTA approves fare changes, including permanent 5-Day Flex Pass

The MBTA Board approved several fare changes that aim to improve equity by closing gaps in existing fare structures for Reduced Fare Riders, minimize pandemic-related revenue implications and budget uncertainties while increasing ridership where possible, and simplify fare tariff rules as the MBTA's Fare Transformation moves forward. These fare changes go into effect on July 1, 2022, with the exception of the 5-Day Flex Pass being made permanent, which goes into effect immediately.

"We're grateful to the Board for approving these fare changes, which prepare us for technology updates to come through Fare Transformation, increase equity through improvements to Link-Passes, especially for our Reduced Fare Riders, and make the 5-Day FlexPass permanent for Commuter Rail riders," said MBTA General Manager Steve Poftak. "These fare updates allow us to continue to meet the needs of riders while minimizing revenue implications in this time

Permanent 5-Day Flex-Pass on mTicket for Commuter Rail:

First introduced as a pandemic fare pilot in June 2020, the 5-Day FlexPass available on mTicket for the Commuter Rail is a bundled fare valid for any five days of travel within a 30-day period. Good for unlimited travel within a 24-hour period, these five passes are available for 10% off the cost of 10 one-way trips. An attractive option for riders whose travel patterns have changed due to hybrid work schedules and the availability of remote-work options, the 5-Day FlexPass on mTicket is now permanent effective immediately.

Reducing Price of the 1-Day LinkPass:

Effective July 1, 2022, and in an effort to increase ridership by encouraging more riders to buy passes and increase equity for low-income and minority riders who often purchase this fare product, the cost of the 1-Day LinkPass will be lowered from \$12.75 to \$11. An \$11 LinkPass pays for itself with five subway rides taken in 24 hours.

Expanding Second Transfers on Buses, Express Bus Routes, and/or Subway:

Currently, the MBTA only allows one transfer between Bus and/or Subway with one recent addition - CharlieCard riders may transfer from Bus to Subway to Bus. To simplify complexities in the T's transfer policy, the transfer process will be standardized to allow all combinations of second transfers involving Buses, Express Bus Routes, and/or Subway, including Bus-Bus-Subway, Subway-Bus-Bus, and Express Bus-Express Bus. This second transfer on Subway and Buses and transfers between Express Routes goes into effect on July 1, 2022.

Changes for Reduced Fare Riders:

Some riders are eligible for reduced fares, including people with disabilities and Medicare cardholders, people 65 and older, some middle and high school students, and people 18 - 25 with low income. Three fare changes that aim to improve equity by closing gaps in existing fare structures for Reduced Fare Riders will go into effect on July 1, 2022:

· Introducing the 7-Day LinkPass for Reduced Fare Riders:

Aiming to increase equity by increasing the benefits of purchasing fares in bulk for Reduced Fare Riders, a 7-Day LinkPass for Reduced Fare riders will be available for \$10, which breaks even after nine subway rides. This product is designed to meet the needs of individuals who might not have enough cash on-hand to afford a monthly pass, but who qualify for Reduced Fare programs.

· Introducing Monthly Passes for Reduced Fare Riders on Commuter Rail, Ferry, and Express Bus:

In order to increase equity by closing gaps in the T's offering of products for Reduced Fare Riders, monthly passes on Commuter Rail, Ferry, and Express Bus for Reduced Fare Riders will be made available. This update offers a full set of monthly passes for Reduced Fare Riders at approximately 50% of the full fare pass

· Expanding Availability of the LinkPass for Reduced Fare Riders on Commuter Rail Zone 1A and Inner Harbor Ferry:

Currently, a LinkPass for Reduced Fare Riders is only available on CharlieCard fare media instead of a printed "flash pass" CharlieTicket that Commuter Rail conductors and ferry staff can see to visually validate a fare. In the future, as more updates take place as part of Fare Transformation, customers will be able to use tappable tickets as well as Charlie Cards to travel on the Commuter Rail and Ferries. As such, and to increase access and equitable pricing on Reduced Fare passes, the LinkPass for Reduced Fare Riders will be expanded to be valid for Commuter Rail travel in Zone 1A and on the Charlestown Ferry.





NEWS FROM AROUND THE REGION

CHELSEA IS IN SOLID FINANCIAL **SHAPE**

CHELSEA - The city is still catching up on the auditing process for its finances, thanks to the pandemic, but the latest results still show Chelsea to be in solid financial shape.

Representatives from the independent auditing firm of Rosselli and Clark Associates appeared before the City Council's finance subcommittee on Wednesday, March 16 to discuss the Fiscal Year 2020 audit and financial report.

City auditor Edward Dunn noted that the city is currently in the tail end of FY22, and that the audit is from FY 20. Tony Rosselli of Roselli and Clark said that because of information that has been delayed at the state level, many audits have been delayed, but that he expected the audits for Chelsea to get back on schedule fairly quickly.

Rosselli said there are many positive economic indicators for the city in the FY20 audit, including over \$40 million in reserve funds and a high bond rating. Rosselli also discussed what an independent audit is, and what it can accomplish.

"The first thing the public is thinking when you are doing an audit is that you are going to look at everything and you are going to look at everything and you are going to find everything, that if someone took something for \$5, we're going to know where it is," said Rosselli. "That's not really what an audit is. An audit is more of a process put out ... by the Government Accounting Office in Washington."

During the process, the auditors may identify if there is anything unusual which could point to a misappropriation, but Rosselli said the auditors don't go into the process with the express purpose of finding misappropria-

"This audit is really intended to go out to all of your bond holders," he said. In addition, copies also go out to the federal government to make sure the city is in compliance with federal grants and to the division of local affairs at the state level.

Rosselli said the audit showed a clean opinion, showing no major qualifications or areas of con-

The economic trends for FY20 showed about \$43 million of reserve funds in the city coffers.

"The reserve funds peaked back in 2017 at about \$45 million, and it looks like it is making its way back there, which is a great place to be for the city," said Rosselli.

The amount of money in reserve compared to the city's expenses was at 27 percent, which is almost three times the state average. Rosselli said that number puts Chelsea in a good position for its bond In addition, for the year

audited, the city's expenses were \$5.5 million under budget, and its revenues exceeded expectations by \$6.2 million, creating a surplus of \$11.7 million.

"Your bond rating is a double A, which is a very good investment grade and one step below the triple A," said Rosselli, allowing the city to get good interest rates when it bonds for capital projects.

The only thing keeping the city from the highest

bond rating is its demographics, especially compared to wealthier communities such as Newton and Wellesley.

The audit also showed the city is in good shape funding its pension liability, which was 76.5 percent funded in the FY20 audit, compared to the state average of 65 percent.

The audit did show that there are almost 100 smaller accounts in the city which have not been used for at least a year or two that should be closed out. The total amount in those accounts is about \$600,000.

City Manager Thomas Ambrosino said the auditor's office is in the process of going through those accounts so that the money can be earmarked for current programs or projects in the city.

PIERS PARKS III **RECEIVES** MORE FUNDING

EAST BOSTON - The Piers Park Phase III project being spearheaded by the Trustees of Reservations (The Trustees) just received an influx of cash from the federal government.

The Trustees nounced this week that U.S. Senator Elizabeth Warren and U.S. Senator Edward J. Markey was able to secure \$2 million for the East Boston waterfront park project through Congressional Directed Spending (CDS) federal funding. Senators Warren and Markey's efforts were supported in the House by U.S. Congresswoman Ayanna Pressley.

The award was included in the bipartisan omnibus federal budget signed by President Joseph R.

"I'm proud to work with my colleagues to bring tens of millions to Massachusetts to grow community-based ects that serve our families, businesses, and cities and towns every day," said Markey. "Bringing a world-class, climate resilient park to the environmental justice community of East Boston will strengthen our resiliency and our economy, while ensuring that locals can access public green space."

After several community workshops and information gathered through an online survey, the Trustees and Michael Van Valkenburgh Associates, Inc., released the newest design of Piers Park III at a Community Design Review meeting last month.

These new design elements gathered through public feedback courtesy of Eastie residents includes less open water in favor of larger and more accessible landscapes.

The new design main tains unique and exceptional public access to the water with an additional access point to the uplands area of the park while preserving the site's maritime history.

The new design also adds more areas for habitats and robust ecological zones within the park such as a tidal pool and salt marsh.

"The Massachusetts delegation and I secured \$2 million in federal funds to design and construct the future Piers Park III in East Boston, which has long held a disproportionate burden of pollution and climate change," said Warren. "This park will serve as an example of a climate-resilient greenspace for our nation, and I look forward to seeing the park flourish as a hub of recreational activity for the entire community." Three years ago, the

Trustees of Reservations submitted the only bid to Massport's call for a private/public partner to come forward and help fund the design and construction of Piers Park Phase III. The dilapidated pier

is adjacent to Massport's award winning Piers Park and the future Piers Park Phase II project.

The Trustees of Reservations operate 120 miles of protected coastline, which includes over North End. "The updated design for

60 miles of trails, and a bunch of beaches and all sorts of other natural habi-

tats in the state.

Massport has

working with the community and other stakeholders over the last two to three years to build out Piers Park Phase II. It was around this time the Trustees of Reservations started having conversations with Massport about their waterfront initiative.

Since being designated, the Trustees Boston Waterfront Initiative team has increased community outreach and engagement to gather feedback on the Piers Park III design and future programming opportunities in the park.

"These federal sources will help initiate, strengthen, and expand community-based projects that serve our families and communities every day," said Pressley. "This world-class waterfront park, designed in close partnership with the environmental justice community of East Boston-will provide a resilient outdoor green space for all to enjoy. I'm proud to have helped deliver these resources and look forward to seeing these critical projects move forward."

The \$2 nillion will contribute to the construction of the park – an estimated \$35 to \$40M project that is being funded largely through philanthropic contributions The Trustees is raising from a mix of private individuals, foundations and corporations. To date, \$28.5M has been committed to build Piers Park III.

"We are grateful to Senator Warren, Senator Markey, and Congresswoman Pressley for their leadership in advocating for these funds, which bring us closer to creating an iconic public space on Boston's Harbor," said Trustees President and CEO John Judge. "Protecting outdoor spaces for everyone is at the heart of our mission—and the reason behind our founding in Boston 130 years ago. Free and open to the public, Piers Park III will be a welcoming and resilient space, for generations to come." Throughout the com-

munity process Eastie residents indicated a desire for better integration with neighboring Phases I and II of Piers Park. Altogether, Piers Park

Phases I, II, and III will provide 14.5 acres of public open space – a landscape more than twice the size of Christopher Columbus Park in Boston's

MS-13 MEMBER **SENTENCED** LYNN - An MS-13 member was sentenced yesterday in federal court

in Boston for RICO conspiracy and for his participation in the July 2018 murder of a teenage boy who was stabbed at least 32 times in a public park

Eliseo Vaquerano Canas, a/k/a "Peligroso," 22,

a Salvadorian national, was sentenced by U.S. Senior District Court Judge Mark L. Wolf to 43 years in prison and five years of supervised release. Vaquerano will be subject to deportation proceedings upon completion of his sentence. In February 2021, Vaquerano pleaded guilty to conspiracy to conduct enterprise affairs through a pattern of racketeering activity, also known as RICO conspiracy, on behalf of the MS-13 gang. As part of his racketeering activity, Vaquerano participated in the 2018 murder of a teenager, who was murdered with extreme atrocity and cruelty, and with deliberate premeditation, in violation of

Massachusetts and numerous other states, as well as countries such as El Salvador, Honduras, and Guatemala. MS-13 gang members often commit acts of extreme violence against suspected rivals, those suspected of cooperating with law enforce-

Relive the early days of the USS Constitution, when the ship was launched by a young nation to battle pirates off Africa's Barbary Coast.

'Old Ironsides' (1926), an epic silent adventure film, will be screened with live music on Friday, April 29 at 6 p.m. at the Custom House Maritime Museum, 25 Water St., Newburyport, Mass.

Admission is \$15 per person. Live music for the sea-going tale will be provided by Jeff Rapsis, a New Hampshire-based silent film accompanist.

The film tells the story of the early days of the USS Constitution, today the world's oldest commissioned naval vessel still afloat. Launched in 1797, she was one of six original frigates authorized by the Naval Act of 1794 and the third constructed.

Nicknamed 'Old Ironsides,' the vessel was originally scheduled to be broken up in 1830, the end of her normal service life. But the ship was saved that year by a poetic tribute published by Oliver Wendell Holmes.

The poem supplied the story for the movie 'Old Ironsides' nearly a century later. Directed by James

Cruze, 'Old Ironsides' is an action/adventure film that traces the story of the

lantic, the Esther is attacked by pirates off the coast of Algiers in the south Mediterranean Sea, with the crew and passengers taken captive. Will the USS Constitu-

tion arrive in time to save the ship's daughter from being presented as a gift to a Sultan in Algiers? The film, a big-budget

extravaganza from Paramount Pictures, boasts an all-star silent era cast that includes Wallace Beery, George Bancroft, Charles Farrell, and Esther Ralston. Among the crew mem-

bers is Boris Karloff, famous later for his starring role in 'Frankenstein' (1931) and as the narrator of the animated version of the classic Dr. Seuss tale 'How The Grinch Stole Christmas' (1966). 'Old Ironsides' was

filmed at sea off the coast

of California's Catalina Island, using a full-scale replica of the original ship. The movie was praised for its authenticity and commitment to historical accuracy. Only a handful of scenes used small-scale models, a rarity for the

In addition to its elaborate battle scenes, the film is notable for its high quotient of comedy. At the time, Hollywood was first starting to make motion pictures with stories that delivered all-around entertainment. Cruze was among the directors becoming adept at integrating comedy, drama, romance, and action all into one spectacular audience-pleasing package. In its original release,

'Old Ironsides' sank at the box office. Critics praised the film, but Jazz Age audiences failed to flock to the historic epic, which was released at the height of the Roaring '20s. See the sea-faring epic

ment, and others who the gang views as a threat. In recent years, dozens of MS-13 members have been convicted of RICO conspiracy and other serious felonies in the District of Massachusetts. MS-13 is organized

into "cliques" or branches operating in local territories. Vaquerano belonged to the "Sykos Locos Salvatrucha" clique of MS-13, which operated in the cities of Lynn, Chelsea, and other parts of Massachusetts. MS-13 has various ranks, with elevation to "homeboy" status generally requiring the commission of a significant act of violence. Evidence showed that Vaquerano had achieved homeboy status in MS-13 even prior to the July 2018 murder. Evidence also showed that Vaquerano helped recruit young members on behalf of the gang, including at Chelsea High School.

In November 2018, Vaguerano and five other MS-13 Sykos clique members were indicted following an investigation into the murder of a teenage boy, whose body found in a park in Lynn on Aug. 2, 2018. The six defendants in this case included five participants in the murder, as well as one longstanding member of the Sykos clique. In a related case, the government charged a juvenile co-conspirator who was the sixth person involved in the murder. The evidence in this

case, which included a recording of one of Vaquerano's co-defendants describing the murder in graphic detail, revealed that Vaquerano Canas and five other MS-13 gang members murdered the victim based on their mistaken belief that he may have been assisting law enforcement. On July 30, 2018, the

six gang members lured the victim to a public park. At least four of the attackers, including Vaquerano, were armed with knives. The group pretended to be friendly with the unsuspecting victim and took him to a wooded area of the park where they surrounded the victim and repeatedly stabbed him to death. At least four of the six assailants took part in stabbing the victim. Vaquerano had an especially active role in the brutal attack. Evidence showed that as the victim was being attacked, he called out to Vaquerano for help, believing that Vaquerano was his friend. Instead, Vaguerano repeatedly stabbed and hacked at the victim with a large knife. Vaquerano attacked the victim with such force that parts of his large knife shattered, and pieces of the blade were embedded into the victim's skull.

After killing the victim, the gang members left his body in the wooded area of the public park where it was discovered days later, on Aug. 2, 2018. An autopsy revealed that the victim suffered at least 32 distinct sharp force trauma wounds consistent with being stabbed repeatedly, along with multiple blunt force injuries.

All six defendants indicted in this case, along with the juvenile charged in the related case, have pleaded guilty. Vaquerano is the fifth defendant to be sentenced in the case. On Feb. 14, 2022, Erick Lopez Flores, a/k/a "Mayimbu," was sentenced to 40 years in prison. On Feb. 15, 2022, Jonathan Tercero Yanes, a/k/a "Desalmado," was sentenced to 33 years in prison. On Feb. 16, 2022, Henri Salvador Gutierrez, a/k/a "Perverso," was sentenced to life in prison. On Feb. 18, 2022, Djavier Duggins, a/k/a "Haze," was sentenced to 15 years in prison. A sentencing hearing for the remaining co-defendant, Marlos Reyes a/k/a "Silencio," has not

Winthrop loses an estimated \$1.1M annually in non-revenue water. Another image showed Winthrop in the bottom 50 percent of U.S. water systems in general and in the bottom 10 percent in terms of "real losses." As a result, customers are paying an average of \$232 extra per year. To minimize losses, En-

vironmental Partners recommended that Winthrop expand its pool of leak detection contractors and technologies, and research water main replacement options in coastal areas. **Environmental Partners**

commented that it could not confirm some basic information about Winthrop's water system due to lack of records. The auditor could not verify the length of mains, the number of service connections. or the duration of services. The DPW provided the consultants with a system map from 1991, but it was unclear if there had been updates since then. As a result, Environ-

mental Partners suggested that Winthrop modernize and digitize all of its water system records. This would improve record security, ease of access and sharing, analysis and loss detection, and response times to failures. The town can realize this transition in stages. Councilors reacted

with concerned questions, though they didn't propose any next steps at the meeting. Councilor Rob DeMarco remarked that the town's water rates were already high and asked if relief to residents would be possible. During the public comment period, one resident commented on a statistic from MWRA regarding high levels of chloroform in the

town water.




